The following are in effect for ALL commercial openers in Willapa Bay:

- Retention of STURGEON OR STEELHEAD is PROHIBITED. ALL encounters MUST be reported to Wholesale Buyer or Quick Reporting.
- For QUICK REPORTING (by 10am the day following landing), NOTICE OF INTENT, and reporting GREEN STURGEON or STEELHEAD ENCOUNTERS USE: Telephone 1-866-791-1280, Fax 360-249-1229; or email harborfishtickets@dfw.wa.gov
- **Notice of Intent to fish any opener during 2019 is REQUIRED by 5 p.m. August 23, 2019.**
- All participants MUST have attended a "Fish Friendly" best fishing practices workshop and have their department-issued certification card in their immediate possession.
