Westslope Cutthroat Trout would be translocated from (a) geographically proximate wild population(s) to Smalle Creek in fall 2019 and as needed in future years to establish, then augment, a self-sustaining population.

7. Do you have any plans for future additions, expansion, or further activity related to or connected with this proposal? If yes, explain.

Initial translocation in 2019 is intended to establish a self-sustaining, naturally reproducing population of Westslope Cutthroat Trout in Smalle Creek. The established population will be monitored in coming years to ascertain performance. If needed to augment numbers or genetics, one or more additional translocations of Westslope Cutthroat Trout to Smalle Creek could occur.

8. List any environmental information you know about that has been prepared, or will be prepared, directly related to this proposal.

Smalle Creek (tributary to Calispell Creek) was stocked with non-native Brook Trout as early as 1916, which established naturalized populations. Washington Department of Fish and Wildlife, in partnership with the Kalispel Tribe and the Pend Oreille Public Utility District #1, conducted rotenone treatments in 2015-2017 to eradicate non-native fish from upper Smalle Creek. This proposal would translocate native Westslope Cutthroat Trout to Smalle Creek to establish a self-sustaining, reproducing population in the watershed above Smalle Creek Falls.

Approximately 500 Westslope Cutthroat Trout will be collected from geographically proximate populations and translocated to Smalle Creek in summer/fall 2019. Fish will be planted throughout the watershed above Smalle Creek Falls to establish a self-sustaining population.

Although the initial translocation may be sufficient to fulfill this objective, additional translocations may be necessary to augment numbers or genetics of the population based on continued monitoring.

Smalle Creek is a small (0.5-2 cfs), spring sourced, perennial tributary to Calispell Creek in southern Pend Oreille County. Smalle Creek flows east/southeast for approximately 15 miles from source to mouth. A series of falls are located approximately 7.25 miles upstream from the mouth of Smalle Creek, creating a barrier to upstream fish passage.

Wild, native Westslope Cutthroat Trout will be translocated into Smalle Creek from geographically proximate populations.

Access to the project area on Smalle Creek is extremely limited and very difficult. The creek is located largely within the United States Forest Service Colville National Forest. The project area of Smalle Creek flows through a single section owned by a large timber company. Some commercial logging has occurred within the watershed, but not within the last 15-20 years. The drainage and surrounding areas support public recreation including hunting, fishing, berry picking, etc.
