Background summary:

"The Department received a petition to delay opening day for recreational anglers on the Skykomish River from May 25 to June 15 and to enact selective gear rules from July 15 to January 31."

Steelhead and salmon fisheries in the Snohomish system are co-managed under annual fishing season setting processes. Steelhead seasons are agreed to in the annual *Stock Status and Harvest Management Plan for Winter and Summer-run Steelhead Returning to the Snohomish and Stillaguamish rivers* in order to meet harvest and conservation objectives. Salmon fisheries are developed and agreed to in the annual North of Falcon process; this also includes rule changes such as selective gear rules. Both steelhead and salmon fisheries are permitted by NOAA under the *Endagered Species Act Section 7(a)(2) Biological Opinion and Management Stevens Fishery Conservation and Management Act Essential Fish Habitat Consultation.*

In 2019, summer steelhead and summer Chinook fisheries opened on the Saturday before Memorial Day. 2019 fisheries impacts on wild steelhead populations met conservation objectives and were estimated to below the allowable 4.2% impact rate as permitted under the ESA.

Staff recommendation:

Deny the rule changes requested in the petition as written. Although the petition is specific to steelhead, the changes would significantly affect hatchery Chinook and hatchery steelhead fisheries. The rule change(s) are appropriate for consideration for the upcoming North of Falcon public season setting process.
