WAC 220-312-04000F Freshwater exceptions to statewide rules—Puget Sound.

Notwithstanding the provisions of WAC 220-312-040, effective November 16, 2019 until further notice, the following areas are closed to salmon angling:

- (1) **Green (Duwamish) River (King Co.):** from an east-west line extending through the southernmost tip of Harbor Island to Tukwila International Blvd./Old Hwy. 99 to the Tacoma Municipal Watershed Boundary Marker (1 mile downstream of Tacoma Headworks Dam)
- (2) **Kennedy Creek (Thurston Co.):** from the mouth (500 yards east of the northbound Hwy. 101 Bridge) to the northbound Hwy. 101 Bridge
