EMERGENCY RULE

Under RCW 34.05.350 the agency for good cause finds:

- That immediate adoption, amendment, or repeal of a rule is necessary for the preservation of the public health, safety, or general welfare, and that observing the time requirements of notice and opportunity to comment upon adoption of a permanent rule would be contrary to the public interest.
- That state or federal law or federal rule or a federal deadline for state receipt of federal funds requires immediate adoption of a rule.

Reasons for this finding: This emergency rule is needed to close commercial purse seine and gillnet salmon fisheries in Puget Sound Salmon Management and Catch Reporting Area 7B beginning November 26, 2019. In season observations indicate lower than normal chum returns to this date. These conservation measures are necessary to ensure that hatchery broodstock and escapement goals are met. There is insufficient time to adopt permanent rules.
