**Background summary:** The commission will adopt or amend department recommended rule changes for:

- WAC 220-415-050 2018-2020 Elk general seasons and definitions.
- WAC 220-415-060 2019 Elk special permits.

Staff presented several recommendations in March 2020 that were minor or administrative in nature, and the Department does not recommend any changes from what was presented at that time.

Given the current status of the Colockum (~18% below objective) and the Yakima (~14% below objective) elk herds, the Department postponed the development of a final recommendation to the Commission until 2019 harvest data and 2020 survey data become available. Department staff met on March 17 to develop the recommendations as presented below.

### **Staff recommendation:**

#### Colockum Elk Herd

GMUs: 249, 251, 328, 329, 330, 334, 335  
Core Herd Area: GMUs 328 and 329

Population surveys indicate the Colockum elk herd declined by an additional 300-400 elk from spring 2019 to spring 2020 and is currently 18% below objective. Antlerless harvest averaged 327 elk during the 2018 and 2019 hunting seasons. Without a substantial reduction in the harvest of antlerless elk during the 2020 season, the Colockum elk herd is likely to experience further declines. To promote population stability or growth, the Department is proposing the following recommendations with the objective of harvesting no more than 100 antlerless elk, to include elk harvested in association with efforts to mitigate conflict issues:

1. Eliminate opportunities to harvest antlerless elk during early and late general archery seasons in GMUs 328 and 329.
2. Retain opportunities to harvest antlerless elk during general archery seasons in areas where the Department does not manage for large numbers of elk (GMUs 249, 334, and 335).
3. Offset some of the opportunity lost by issuing a limited number of special permits that allow archery hunters to harvest antlerless elk. Special permit season dates will overlap general season dates and will include 75 permits during the early season and 20 permits during the late season.
4. Reduce the number of modern firearm special permits for antlerless elk from 85 to 45.
5. Reduce the number of muzzleloader special permits for antlerless elk from 60 to 30.
6. Eliminate special permits opportunities to harvest antlerless elk for Youth (30), Senior (65+, 15 permits), and Hunters w/ Disabilities (10 permits).

## Yakima Elk Herd

GMUs: 336, 340, 342, 346, 352, 356, 360, 364, 368, 371, 372

Core Herd Area: GMUs 336, 340, 342, 346, 352, 356, 360, 364, 368

The Yakima herd was approximately 14% below objective when the Department conducted population surveys in spring 2019. We were not able to conduct a population survey to estimate abundance in 2020 because mild winter conditions prevented elk from concentrating on traditional winter range. However, the Department classified approximately 4,000 elk on feed sites throughout winter and estimated the calf:cow ratio to be 19:100. The only other time calf:cow ratios have been documented this low for the Yakima herd was following the severe winter of 2016/2017. Although the Department was not able to estimate abundance, it is likely the Yakima herd declined again in 2020 with calf:cow ratios this low, or at best, remained stable.

Antlerless harvest averaged 275 elk during the 2018 and 2019 hunting seasons. Without a reduction in the harvest of antlerless elk during the 2020 season, the Yakima herd is likely to experience further declines. To promote population stability or growth, the Department is proposing the following recommendations with the objective of harvesting no more than 150 antlerless elk, to include elk harvested in association with efforts to mitigate conflict issues.

1. Eliminate all opportunities to harvest antlerless elk during early and late general archery seasons in GMUs 336, 340, 342, 346, 352, 356, 364, and Elk Area 3681.
2. Offset some of the opportunity lost by issuing a limited number of special permits that allow archery hunters to harvest antlerless elk. Special permit season dates will overlap general season dates and will include 280 permits during the early season and 110 permits during the late season.
3. Reduce the number of modern firearm special permits for antlerless elk from 170 to 75.
4. Reduce the number of muzzleloader special permits for antlerless elk from 100 to 60.
5. Reduce the number of special permits for Youth hunters to harvest antlerless elk in the core area from 50 to 26 and add 30 Youth permits in GMU 371.
6. Reduce the number of special permits for Senior (65+) hunters to harvest antlerless elk in the core area from 30 to 21.
7. Reduce the number of special permits for Hunters w/ Disabilities to harvest antlerless elk in the core area from 20 to 11.

### **Policy issue(s) and expected outcome:**

- Maximize recreational elk hunting opportunity.
- Continue sustainable hunting seasons for elk
- Clarify language to avoid confusion for hunters.

AMENDATORY SECTION (Amending WSR 19-20-078, filed 9/27/19, effective 10/28/19)

**WAC 220-415-050 2018-2020 Elk general seasons and definitions.**

It is unlawful to fail to comply with bag, possession, and season limits described below. A violation of this section is punishable under RCW 77.15.410 Unlawful hunting of big game—Penalty.

**Bag Limit:** One (1) elk per hunter during the license year, except where otherwise permitted by department rule. Any combination of seasons, tags, and permits set by the department will not exceed a maximum of two (2) elk per hunter during the license year.

**Hunting Method:** Elk hunters must select only one of the hunting methods: Modern firearm, archery, or muzzleloader.

**Elk Tag Areas:** Elk hunters must choose either Eastern or Western Washington to hunt in and buy the appropriate tag for that area.

**Any Bull Elk Seasons:** Open only to the taking of elk with visible antlers; bull calves are illegal.

**Antler Point:** To qualify as an antler point, the point must be at least one inch long, measured on the longest side.

**Branch:** A branch is defined as any projection off the main antler beam that is at least one inch long, measured on the longest side, and longer than it is wide.

**Spike Bull Antler Restrictions:** Bull elk taken in spike-only game management units (GMUs) must have at least one antler with no branches originating more than 4 inches above where the antler attaches to the skull.

**Spike-only GMUs:** 145-154, 162-186, 249, and 336-368.

**True Spike - Bull Antler Restrictions:** Neither antler of bull elk taken in GMUs 251, and 328-335 can have branching originating more than 4 inches above where the antlers attach to the skull. Under the true-spike restriction, taking an elk that has two points on one side or antler points within one inch of the definitions regarding length of point, or point of origination, is an infraction under RCW 77.15.160. All other types of violations of the true-spike restriction are subject to current penalties and assessments under RCW 77.15.410 and 77.15.420.

**True-spike GMUs:** 251, 328-335.

**3-point Antler Restrictions:** Legal bull elk must have at least 3 antler points on one side. Eye guards are antler points when they are

at least one inch long. Antler restrictions apply to all hunters during any open season.

**3-point GMUs:** All of Western Washington, except for GMUs 448, 454, 564, 652 for archers, 666, 684, and Elk Area 4941.

**Permit-only Units:** The following GMUs are closed to elk hunting during general elk seasons: 157, 371, 418, 485, 522, 556, 621, 636, and 653.

**GMUs Closed to Elk Hunting:** 437 (except for Elk Area 4941) and 490.

**Areas with Special Restrictions:** There are modern firearm restrictions in GMU 334 and portions of GMU 660. GMU 554 is open only for early archery and muzzleloader seasons. Elk Area 6064 in GMU 638 (Quinault) is open to master hunters only.

**Eastern Washington:** All 100, 200, and 300 GMUs.

EA - Eastern Washington Archery Tag

EF - Eastern Washington Modern Firearm General Elk Tag

EM - Eastern Washington Muzzleloader Tag

**Western Washington:** All 400, 500, and 600 GMUs.

WA - Western Washington Archery Tag

WF - Western Washington Modern Firearm General Elk Tag

WM - Western Washington Muzzleloader Tag

**License Required:** A valid big game hunting license with an elk tag option.

**Tag Required:** A valid modern firearm elk tag as listed below for the area hunted.

**Hunting Method:** May use modern firearm, bow and arrow, crossbow, or muzzleloader, but only during modern firearm seasons.

**Tag Required:** A valid archery elk tag as listed below for the area hunted.

**Hunting Method:** Bow and arrow only, as defined under WAC 220-414-070.

**Special Notes:** Archery tag holders can hunt only during archery seasons and must hunt with archery equipment (WAC 220-414-070).

Archery elk hunters may apply for special bull permits. Please see permit table for tag eligibility for all elk permits.

**Hunting Method:** Muzzleloader, as defined under WAC 220-414-060, or bow and arrow, as defined under WAC 220-414-070.

**Special Notes:** Muzzleloader tag holders can only hunt during the muzzleloader seasons. Only hunters with tags identified in the Special Elk Permits tables may apply for special elk permits.

## **RECOMMENDED ADJUSTMENTS**

The department recommends the following adjustments since the Code Reviser filed (CR-102). The adjustments are included in your notebooks.

### **Page 5**

- Change: Under Early Archery General Elk Seasons, Eastern Washington, eliminate the season where a legal elk is Antlerless for GMUs 328, 329, 336, 340, 352, 356, 364.

Rationale: General season opportunities to harvest antlerless elk in these GMUs are being eliminated to promote recovery of the Colockum and Yakima elk herds.

### **Page 6**

- Change: Under Late Archery General Elk Seasons, Eastern Washington, remove GMU 328 from areas that will be open Nov. 25 – Dec. 8 to harvest a true spike bull or antlerless elk

Rationale: General season opportunities to harvest antlerless elk in these GMUs are being eliminated to promote recovery of the Colockum and Yakima elk herds.

- Change: Under Late Archery General Elk Seasons, Eastern Washington, change the Legal Animal from Spike bull or antlerless to Spike bull in GMUs 336, 342, 346, 352, 364, and Elk Area 3681

Rationale: General season opportunities to harvest antlerless elk in these GMUs are being eliminated to promote recovery of the Colockum and Yakima elk herds.

## **Summary of Public Comments Received During the Official Comment Period and WDFW Response:**

WAC 220-415-050 2018-2020 Elk General Seasons and Definitions.

### **Supporting Comments:**

There were sixteen comments in support of the proposal, with most comments being related to proposals for the Colockum and Yakima elk herds. Seven comments expressed an understanding of the need to reduce antlerless harvest and were supportive, but perspectives on how to reduce antlerless harvest differed and included:

- 1) only allowing antlerless harvest through special permit seasons for all user groups.
- 2) reducing antlerless harvest for modern firearm hunters
- 3) reducing antlerless harvest for archery hunters.

Other comments in support of the proposal and related to the Colockum and Yakima elk herds were related to concerns that tribal hunting (2 comments) and predators (2 comments) were factors negatively affecting these herds and should be addressed by the Department. Lastly, one comment supported the reduction of permits in the Mount St. Helens elk herd area and one comment advocated for including GMU 663 (Capitol Peak) to the list of areas open during the late general muzzleloader season in western Washington. Three other comments were unrelated to the proposal.

### **Opposing, Neutral, and Other Comments:**

There were twenty-eight comments in opposition to the proposal, with most comments being related to proposals for the Colockum and Yakima elk herds. Although in opposition of the proposal, seven comments indicated general support for reductions in antlerless harvest, while another four comments advocated for no antlerless harvest or further reductions. Four comments were opposed to reductions in opportunities for archery hunters, three comments advocated for permit only opportunities for antlerless elk, one comment advocated for not reducing special permits for muzzleloader hunters, and one comment advocated for a season that was only for archery hunters using primitive bows. Other comments in opposition of the proposal were related to concerns that tribal hunting (3 comments) and predators (6 comments) were factors negatively affecting these herds. Three comments were related to abolishing spike or true-spike rules, while two other comments were unrelated to the proposal.

There were six neutral comments. Although their stance was neutral, one was generally supportive of reducing antlerless harvest, while three were concerned about the affects of tribal harvest and one advocated for the Department to consider predator management actions. One additional comment was unrelated to the proposal.

The Department also received one email that expressed concern about current status of the Colockum and Yakima elk herds. More specifically, they advocated for removing all antlerless harvest, not having other seasons overlap the Quality bull hunts, eliminating “true-spike”, consider closing both areas to all elk hunting, and better enforcement of the green-dot road system.

Lastly, the Department met with representatives from Washington State Bowhunters, the Washington State Archery Association, and Traditional Bowhunters of Washington to discuss proposals for the Colockum and Yakima elk herds. All three groups expressed strong values associated with providing general season opportunities for archery hunters to harvest antlerless elk.

**Fish and Wildlife Commission Hearing, Public Comments:**

No public testimony in support of this proposal was received at the March Commission meeting and we only received one letter during the extended open comment period that expressed support.

The Department received one comment during public testimony at the March Commission meeting and two comments during the extended comment period that were in opposition to this proposal because they were opposed to eliminating opportunities to harvest antlerless elk in the Colockum and Yakima elk herd areas during the general archery seasons.

The Department also received one comment during the extended comment period that expressed opposition to changing the dates for Master Hunter seasons in GMU 371, while one other comment advocated for having different seasons for each weapon type during seasons only open to Master Hunters in GMU 371 and Elk Area 3911. Lastly, one additional comment in opposition to the proposal advocated for allowing elk to expand into agricultural areas.

**Direction and Rationale:**

The Department will move forward with a recommendation to the Fish and Wildlife Commission to eliminate opportunities to harvest antlerless elk during general archery seasons in the Colockum and Yakima elk herd areas. Surveys of the Colockum elk herd indicate it had declined by an additional 10% from spring 2019 to 2020 and is currently 18% below objective. The Yakima elk herd was 14% below objective in 2019 and mild winter conditions prevented the Department from conducting aerial surveys in 2020 to estimate abundance, but calf:cow ratios from more than 4,000 elk observed on the feed sites were only 19:100. With calf:cow ratios this low, it is likely the Yakima elk herd experienced further declines as well, or remained stable at best. Without substantial reductions in antlerless harvest, the Department anticipates both herds will continue to decline. Moreover, the predator-prey guidelines outlined in the Game Management Plan clearly indicate the Department must attempt to address declining trends for an “at-risk” ungulate population through harvest prior to considering predator management actions.



AMENDATORY SECTION (Amending WSR 19-20-078, filed 9/27/19, effective 10/28/19)

**WAC 220-415-060 ((2019)) 2020 Elk special permits.** It is unlawful to fail to comply with the bag, possession, and season limits described below. A violation of this section is punishable under RCW 77.15.410 Unlawful hunting of big game—Penalty.

**Special Elk Permit Hunting Seasons (Open to Permit Holders Only)**

Hunters must purchase an elk hunting license prior to purchasing a permit application. Hunters may only apply for permits consistent with the tag required for the hunt choice; however, Multiple Season Permit holders may apply for Eastern or Western Washington archery, muzzleloader, or modern firearm permit hunts. Applicants must have purchased the proper tag for these hunts. The elk tag prefixes required to apply for each hunt are shown in the following table. Hunters drawn for a special permit hunt must comply with weapon restrictions, dates, and other conditions listed for the hunt. Hunters drawn for a special permit designated "**Any tag**" under the "**Weapon/Tag**" restriction must use equipment consistent with the requirements of their transport tag and license.

**Bag Limit:** One (1) elk per hunter during the license year except where otherwise permitted by department rule, even if permits are drawn for more than one elk hunt category. Any combination of seasons, tags, and permits set by the department will not exceed a maximum of two (2) elk per hunter during the license year.

## **Summary of Public Comments Received During the Official Comment Period and WDFW Response:**

### WAC 220-415-060 2020 Elk Special Permits.

#### **Supporting Comments:**

The Department received ten comments in support of the proposal. Two comments expressed general support, two advocated for replacing archery general seasons with special permits, one advocated for longer youth seasons in the Yakima herd, one advocated for more opportunity for senior hunters in GMU 560, one advocated for less tribal harvest, one advocated for predator management, and one advocated for less archery opportunity. One additional comment was unrelated to the proposal.

#### **Opposing, Neutral, and Other Comments:**

The Department received twenty-three comments in opposition to the proposal. Five comments advocated for predator management, five expressed opposition to a reduction in permit numbers, three advocated for a reduction in tribal harvest, two advocated against a reduction of bull permits in the Blue Mountains, two expressed general support for the proposal, two were opposed to reductions in opportunities for archery hunters, one advocated for removing all special permits, one advocated for more youth permits, one expressed opposition to reducing special permits for senior hunters, one supported further reductions in antlerless opportunities, one advocated for more opportunity for archery hunters that use traditional equipment, one advocated for more antlerless permits in GMUs 513 and 516, and one thought there were too many special permits for antlerless elk in GMU 648.

The Department received five neutral comments. Two comments advocated for predator management, one comment advocated for more youth permits, and two comments were not related to the proposal.

The Department also received one email that expressed concern about current status of the Colockum and Yakima elk herds. More specifically, they advocated for removing all antlerless harvest, not having other seasons overlap the Quality bull hunts, eliminating “true-spike”, consider closing both areas to all elk hunting, and better enforcement of the green-dot road system.

Lastly, the Department met with representatives from Washington State Bowhunters, the Washington State Archery Association, and Traditional Bowhunters of Washington to discuss proposals for the Colockum and Yakima elk herds. All three groups expressed strong values associated with providing general season opportunities for archery hunters to harvest antlerless elk.

No public testimony in support of this proposal was received at the March Commission meeting, while we received two comments during the extended open comment period that expressed support. One comment expressed general support, while the other comment expressed support for youth permits in GMU 371.

The Department received no additional opposing comments during public testimony at the March Commission meeting. We received one comment during the extended comment period that advocated for antlerless permits in GMU 653, but the constituent did not indicate whether they were supportive of or opposed to the proposal.

**Direction and Rationale:**

The Department will move forward with the recommendation to the Fish and Wildlife Commission as originally proposed, but will also include a recommended adjustment that will add special permit opportunities for archery hunters to harvest antlerless elk in the Colockum and Yakima elk herd areas to offset some of the opportunity that was lost with the elimination of general archery seasons. The most common themes from comments received included advocating for predator management, opposition to reductions in opportunity, and reducing tribal harvest. The Department has already liberalized bear seasons in eastern Washington and is proposing options to recreational cougar seasons that could increase opportunities to harvest cougars. Although the Department attempts to work collaboratively with the 24 tribes that have off-reservation hunting rights, they set their own hunting regulations for their tribal members. Although opposition to a reduction in opportunities was a central theme, those reductions are necessary given the current status of the Colockum (18% below objective), Yakima (14% below objective), Blue Mountains (16% below objective), and Mount St. Helens (30-35% decline in 2019) elk herds.

**Purpose of the proposal and its anticipated effects, including any changes in existing rules:**

WAC 220-410-050 Game management unit (GMU) boundary descriptions—Region five.

The purpose of this proposal is to correct any errors in the boundary descriptions for game management unit 506.

WAC 220-410-060 Game management unit (GMU) boundary descriptions—Region six.

The purpose of this proposal is to correct any errors in the boundary descriptions for game management unit 673.

WAC 220-412-050 Landowner raffle hunts.

The purpose of this proposal is to alter the adjustment of annual report submission date requirements from December 31 to May 1, to coincide with WAC 220-412-100. This also allows enrolled landowners to submit all required reports at the same time.

WAC 220-412-070 Big game and wild turkey auction, raffle, and special incentive permits.

This proposal adds game management units (GMUs) 186 and portions of GMU 181 (south of the line made by starting at Montgomery Ridge Road and Highway 129, to the Sherry Grade Road, to the Couse Creek Road, to the Snake River) to the legal hunt area for the Rocky Mountain Bighorn Sheep Raffle Permit.

WAC 220-412-090 Multiple season big game permits.

The purpose of this proposal is to clarify language.

WAC 220-412-100 Landowner hunting permits.

The purpose of this proposal is to further develop the standard operating procedure for the Landowner Hunting Permit (LHP) Program. The Landowner Hunting Permit WAC has been adjusted to reflect the new proposed requirements for the LHP program, as outlined in the standard operating procedure. The revised standard operating procedure anticipates better management, monitoring, and an improved experience for the general public, while recreating on properties enrolled in the Landowner Hunting Permit.

WAC 220-413-180 Special closures and firearm restriction areas.

The proposed administrative changes remove the reference to “wooden towers” from the description for the Columbia River Restricted Hunting Area. Corrections are made to the spelling of Newberry (from Newbury) Hill Road for the Firearm Restriction Area in Kitsap County.

WAC 220-413-200 Reducing the spread of hoof disease—Unlawful transport of elk hooves.

The purpose of this proposal is to abolish the rule.

WAC 220-415-020 2018-2020 Deer general seasons and definitions.

The purpose of this proposal is to retain general season deer hunting opportunities for 2020. It also aims to balance the hunting opportunities between user groups. The proposal also increases opportunities when deer populations allow and reduces opportunities when declining deer numbers warrant a change.

WAC 220-415-030 2019 Deer special permits.

The purpose of this proposal is to retain special permit for deer hunting opportunities for 2020. It also balances hunting opportunities between user groups, increases opportunities when deer populations allow, and reduces opportunities when declining deer numbers warrant a change. Lastly, it adds language that clarifies the bag limit is one deer, except where otherwise permitted by department rule, even if permits are drawn for more than one deer hunt category.

WAC 220-415-040 Elk area descriptions.

The purpose of the proposed changes would eliminate Elk Area No. 1011 (Columbia County), Elk Area No. 1012 (Asotin County), and Elk Area No. 1082 (Asotin County).

WAC 220-415-050 2018-2020 Elk general seasons and definitions.

The purpose of the proposed change is to retain general season elk hunting opportunities for 2020. It also balances hunting opportunities between user groups, increases opportunities when elk populations allow, and reduces opportunities when declining elk numbers warrant a change.

The department will not develop specific recommendations regarding opportunities to harvest antlerless elk during the early archery general elk seasons in the Colockum (GMUs 328, 329) and Yakima (GMUs 336, 340, 352, 356, 364) elk herd areas until population surveys are completed in February and/or March. If population surveys indicate it is warranted, the department may also consider reducing opportunities for archery hunters to harvest antlerless elk during the late archery general elk seasons, and reducing modern firearm, and muzzleloader special permit opportunities. A general overview of the recommendations that may be considered dependent of herd status are provided below. Recommendations developed in response to surveys indicating a population decline will also depend on the severity of the decline.

Colockum Elk Herd: (GMUs 249, 251, 328, 329, 330, 334, 335)

Replace some of the lost opportunities with a limited number of permits to harvest antlerless elk. If warranted, also reduce opportunities during modern firearm and muzzleloader permit seasons.
Stable	Significantly reduce or eliminate general season opportunities to harvest antlerless elk, except for those associated with addressing damage issues and in areas where the department does not manage for large numbers of elk (e.g., GMU 371 and 372). Replace some of the lost opportunities with a limited number of permits to harvest antlerless elk. Retain current opportunities during modern firearm and muzzleloader permit seasons.
Increase	Retain current general and special permit seasons.

WAC 220-415-060 2019 Elk special permits.

The purpose of this proposal is to retain elk special permit hunting opportunities for 2020. It also balances elk hunting opportunities between user groups, increases elk hunting opportunities when elk populations allow, and reduces opportunities when declining elk numbers warrant a change. Lastly, it adds language that clarifies the bag limit is one elk, except where otherwise allowed by department rule, even if permits are drawn for more than one elk hunt category.

WAC 220-415-070 2019 Moose seasons, permit quotas, and areas.

This proposal adds language that clarifies the bag limit is one moose, except where otherwise allowed by department rule, even if permits are drawn for more than one moose hunt category. It also adjusts moose hunt permit limits to reflect population changes and recent harvest.

WAC 220-415-100 2018-2019 and 2019-2020 Cougar.

The proposed changes are designed to give the Commission four options to choose from relating to recreational cougar harvest guidelines. The non-status quo options are intended to extend seasons in areas where harvest has been historically high, and where cougar human conflict is also high. The intended result of the longer season is to shift a proportion of the cougar removal, currently carried out by agency personnel, to hunters:

- The first option is status quo with one caveat, the density we used to set the guideline is the median of five research projects that were conducted in Washington. The median is a better measure because it is not affected by outliers in the data. In the past we used the mean.

- The second option also uses a median density that is calculated using only adult cougars that are 24 months or older. This option reduces the guideline slightly, but sub-adult cougars harvested under this option would not count toward the guideline for season closure.
- The third option adjusts the guideline upward for units that exceeded the guideline by December 31 at least once in the past five years. The new guideline is based on the highest harvest in the past five years. In this option there is the assumption that density is higher in these areas. In two PMUs, the guidelines in this option were adjusted, so they did not exceed an assumed density 4.15 cougars per 100 square kilometers. This was intended to keep the density within an acceptable range based on research conducted in the western United States. This guideline includes adults and sub-adults.
- The fourth option is like option three, but only uses a density based on adult cougars and only counts adult cougars towards the guideline.

WAC 220-415-120 2019 Bighorn sheep seasons and permit quotas.

This proposal adds language that clarifies the bag limit is one bighorn sheep, except where otherwise permitted by department rule, even if permits are drawn for more than one bighorn sheep category. It also adjusts bighorn sheep hunt permit limits to reflect population changes and recent harvest. Lastly, this proposal creates separate permit opportunities for adult ewes and juvenile rams in the Selah Butte, Mount Baldy, and Umtanum hunt areas (collectively referred to as the Yakima Canyon herd).

WAC 220-415-130 2019 Mountain goat seasons and permit quotas.

This proposal adds language that clarifies the bag limit is one mountain goat, except where otherwise permitted by department rule, even if permits are drawn for more than one goat hunt category. It also adjusts mountain goat hunt permit limits to reflect population changes and recent harvest.

WAC 220-416-010 2018-2019, 2019-2020, 2020-2021 Small game and other wildlife seasons and regulations.

The purpose of this proposal is to increase the number of hunter education incentive turkey permits from two to four.

WAC 220-416-040 Hunting predatory birds.

Removes the depredation part of the rule because it already exists in WAC 220-440-060.

WAC 220-416-060 2019-2020 Migratory gamebird seasons and regulations.

The proposal amends the rule to specify legal season dates, and bag limits for the 2020-2021 season.

Changes include:

- Adjusting season dates relative to 2020-2021 calendar dates.
- Maintain one-pintail per day bag-limit and associated possession limit per the USFWS Northern Pintail Harvest Strategy.
- Lowering scaup bag-limit to two-scaup per day and associated possession limits, while keeping an 86-day season length by the optimal regulatory alternative described in the Adaptive Harvest Management protocol.
- Shifting seven-days from the beginning of the first season segment to the end of the third season segment for white geese in Goose Management Area 4 (Columbia Basin).

WAC 220-440-060 Killing wildlife causing private property damage.

The proposed amendment to the rule intends to make our rule consistent with federal rules that pertain to crows and magpies.

**Reasons supporting proposal:**

WAC 220-410-050 Game management units (GMUs) boundary descriptions—Region five.

The proposed change will make the boundaries more discernable for hunters.

WAC 220-410-060 Game management units (GMUs) boundary descriptions—Region six.

The proposed change will make the boundaries more discernable for hunters.

WAC 220-412-050 Landowner raffle hunts.

This proposal simplifies the requirements for landowners that operate raffle drawings. It also aligns annual report submission dates with WAC 220-412-100.

WAC 220-412-070 Big game and wild turkey auction, raffle, and special incentive permits.

Bighorn sheep populations have increased in these areas, which warrants an expansion of the hunt area.

WAC 220-412-090 Multiple season big game permits.

The proposal clarifies the language and reduces hunter confusion regarding this rule.

WAC 220-412-100 Landowner hunting permits.

Over the past year, the department has held public meetings and active stakeholder/landowner meetings to assess the current views of the program. These comments have been taken into consideration as well as input from Washington Department of Fish and Wildlife (WDFW) staff which has resulted in the development of the new standard operating procedure for the landowner hunting permit (LHP) program. The proposed changes reflect the comments received from the public, WDFW staff and landowners. Historically, there haven't been many changes to the LHP program. However, due to the lack of consistency and the expansive variation in management styles across the state, this program has proven to be difficult to manage at a program level. These reasons were the main driving factor behind taking the appropriate steps to revise and make changes to the program.

WAC 220-413-180 Special closures and firearm restriction areas.

The "wooden towers" referenced in the Columbia River Restricted Hunting Area boundary description were torn down recently. As such, they could no longer be used as a discernable landmark to describe the boundary. Correcting the spelling of Newberry Hill Road will eliminate confusion for hunters.

WAC 220-413-200 Reducing the spread of hoof disease—Unlawful transport of elk hooves.

This rule, originally adopted in 2014, attempted to reduce the risk of inadvertently spreading the causative agents of treponeme associated hoof disease (TAHD) in elk. Since that time, however, TAHD has been confirmed throughout western Washington, east of the Cascade Mountains near the town of Trout Lake, and in the Blue Mountains of southeast Washington. The continued expansion of this disease appears to indicate this rule was ineffective at preventing disease expansion. Other reasons for supporting this rule are:

1. For surveillance purposes, we want to encourage elk hunters in eastern Washington to submit suspicious hooves.
2. The current rule is not being enforced, but rather used by Enforcement Officers as an educational opportunity.
3. We have no scientific findings that support the implementation of this rule.
4. The Department is working on developing management strategies that will be proposed during the next 3-year season cycle, which would incentivize elk hunters in western Washington to target limping elk but would also require them to submit their hooves to the Department for inspection.
5. Neighboring states (Idaho and Oregon), where TAHD has been detected, do not have a similar rule.

Although the Department is proposing to abolish this rule, we would still encourage hunters to leave hooves from the elk they harvest on site.

WAC 220-415-020 2018-2020 Deer general seasons and definitions.

This proposal provides recreational deer hunting opportunities and protects deer from overharvest. The proposal would also maintain sustainable general deer hunting season opportunities for 2020. The proposal helps address deer agricultural damage problems and provides for deer population control when needed.

WAC 220-415-030 2019 Deer special permits.

This proposal provides recreational deer hunting opportunities and protects deer from overharvest. The proposal would also maintain sustainable deer special permit hunting season opportunities for 2020. The proposal helps address deer agricultural damage problems and provides for deer population control when needed.

Situations have occurred in the past that involved hunters who successfully drew a permit in more than one hunt category for the same species. Because the current language does not specify a bag limit, some hunters interpret this to mean they can shoot one deer per permit or one deer in addition to their general season harvest, which is incorrect. Amending this rule as proposed, would clarify the rule and avoid confusion in the future.

WAC 220-415-040 Elk area descriptions.

All three elk areas were created to address issues related to elk causing damage to agricultural crops. Damage issues in all three areas have declined following the substantial declines in elk numbers. As such, these elk areas are no longer needed and there is not an anticipated need in the foreseeable future.

WAC 220-415-050 2018-2020 Elk general seasons and definitions.

Overall, the proposal provides recreational elk hunting opportunities, helps address elk agricultural damage problems, and provides elk population control when needed. The department is postponing the development of specific recommendations for the Colockum and Yakima elk herds. These two herds have experienced substantial declines since 2015, with late-winter surveys in 2019 showing the Yakima herd was approximately 13% below objective and the Colockum herd approximately 8% below. Declines have been the result of increased antlerless harvest, severe drought and winter conditions, and depressed recruitment of calves. Moreover, preliminary counts of elk on feed sites for the Yakima elk herd in January 2020, show calf recruitment rates are likely to be lower than normal for the fourth consecutive year. The department is concerned about the status of both herds and plans to develop recommendations that are likely to promote population growth.

WAC 220-415-060 2019 Elk special permits.

This proposal provides recreational elk hunting opportunities and protects elk from overharvest. The proposal would maintain sustainable elk special permit hunting opportunities for 2020. The proposal helps address elk agricultural damage problems and provides for elk population control when needed.

Situations have occurred in the past that involved hunters who successfully drew a permit in more than one hunt category for the same species. Because the current language does not specify a bag limit, some hunters interpret this to mean they can shoot one elk per permit or one elk in addition to their general season harvest, which is incorrect. Amending this rule as proposed, would clarify the rule and avoid confusion in the future.

WAC 220-415-070 2019 Moose seasons, permit quotas, and areas.

Situations have occurred in the past that involved hunters who successfully drew a permit in more than one hunt category for the same species. Because the current language shows the bag limit is one moose, some hunters interpret this to mean one moose per permit, which is incorrect. Amending this rule as proposed, would clarify the rule and avoid confusion in the future.

Permits for 'Any Antlered Bull Moose' in Spokane West A were increased because surveys showed a good bull to cow ratio. Permits for 'Antlerless Only' were reduced in Mt Spokane South B, Mt Spokane North B, and Mica Peak because surveys showed calf recruitment rates and the overall number of moose biologists observed were lower than normal.

WAC 220-415-100 2018-2019 and 2019-2020 Cougar.

The proposal gives the Commission biologically sustainable options for the cougar hunting seasons.

WAC 220-415-120 2019 Bighorn sheep seasons and permit quotas.

Situations have occurred in the past that involved hunters who successfully drew a permit in more than one hunt category for the same species. Because the current language indicates the bag limit is one bighorn ram, except in designated adult ewe hunts the limit is one bighorn adult ewe, some hunters interpret this to mean one sheep per permit, which is incorrect. Amending this rule as proposed, would clarify the rule and avoid confusion in the future.

The department is proposing to develop unique permit opportunities for adult ewes and juvenile rams for the Yakima Canyon herd. This proposal is in association with our efforts to reduce the size of the herd and eliminate *Mycoplasma ovipneumoniae* (M. Ovi.) from this herd. The department first implemented these permits during the 2019 season with special restriction identified as an Adult Ewe or Juvenile Ram, but most resulting harvest consisted of rams, including rams that were not juveniles. As such, very few ewes were harvested as intended, which calls for the proposed change.

WAC 220-415-130 2019 Mountain goat seasons and permit quotas.

Situations have occurred in the past that involved hunters who successfully drew a permit in more than one hunt category for the same species. Because the current language shows the bag limit is one adult goat of either sex with horns four inches or longer, some hunters interpret this to mean one adult goat per permit, which is incorrect. Amending this rule as proposed, would clarify the rule and avoid confusion in the future.

WAC 220-416-010 2018-2019, 2019-2020, 2020-2021 Small game and other wildlife seasons and regulations.

This change increases the incentive for hunter education instructors without harm to turkey populations.

WAC 220-416-040 Hunting predatory birds.

Reduces redundancy and simplifies the rule.

WAC 220-416-060 2019-2020 Migratory gamebird seasons and regulations.

Migratory waterfowl and other gamebird (coot, dove, band-tailed pigeon, and snipe) seasons and regulations are developed based on cooperative management programs among states of the Pacific Flyway and the U.S. Fish and Wildlife Service, considering population status and other biological parameters. The rule establishes waterfowl seasons and regulations to provide recreational opportunity, control waterfowl damage, and conserve the migratory waterfowl resources of Washington.

WAC 220-440-060 Killing wildlife causing private property damage.
