

# SEPA ENVIRONMENTAL CHECKLIST

## ***Purpose of checklist:***

Governmental agencies use this checklist to help determine whether the environmental impacts of your proposal are significant. This information is also helpful to determine if available avoidance, minimization or compensatory mitigation measures will address the probable significant impacts or if an environmental impact statement will be prepared to further analyze the proposal.

**The proposed project is to construct 1.6 miles of boundary stock fencing on the 4-0 unit of the Chief Joseph Wildlife Area. The fencing will be no more than 54 inches high at posts and 48 inches high at cross wires. Fencing will consist of steel T-posts that will be driven into the ground by hand and wrapped with three rows of wire (see maps/plans). The fencing allows wildlife to pass while preventing livestock from entering the area.**
