### Friday, September 11, 2020

Chair Carpenter called the meeting to order at 8:00 a.m.

#### **1. Call to Order**

##### **a. Commissioners' Discussion**

Chair Carpenter paid respects to the late Bob Lake, longtime Willapa Bay advocate.

There are no lands transactions for decision. The item was struck from the agenda.

Commissioner McIsaac shared a graph outline the increased [daily adult counts at Bonneville Dam for adult Chinook](#).

Chair Carpenter shared that he and Commissioner Baker with DFW leadership met with Oregon Commission leadership. They discussed collaboration and concurrence efforts moving forward into the future.

##### **b. Meeting Minute Approval**

The Commission considered approval of the July 31-August 1, 2020 and August 21, 2020 meeting minutes.

**Commissioner Thorburn made motion, seconded by Commissioner Anderson, to approve the minutes of the July 31-August 1, 2020 webinar as presented. All in favor. Motion passed.**

**Commissioner Thorburn made motion, seconded by Commissioner Anderson, to approve the minutes of the June 26, 2020 webinar as amended. All in favor. Motion passed.**

**c. Committee Reports - This Section constitutes the formal minutes from each of the listed committee meetings:**

**Wildlife Committee**

**Commissioners in attendance: Anderson, Baker, Thorburn, Linville**

Commissioner Thorburn reported that the committee discussed the potential of porcupine and rattlesnake dog aversion training. The Commission asked staff to develop a white paper on the issue and to come back to the committee.

The committee recommended to the full Commission that aversion training proceed to rule develop in a limited capacity, specially for the two species, under the directors permitting process.

The Commission supported the recommendation and asked the staff to move forward with rule development.

The committee was also given a brief overview of the species impacts by the fire damage in the state and the outlook of upcoming hunting seasons. Details on the damage and season development will be provided during the directors' report.

**Fish Committee**

**Commissioners in attendance: Kehoe, Graybill, McIsaac, Anderson, Linville, Baker**

Commissioner McIsaac reported out for the committee.

Under the Hatchery Policy C-3619 item even though some public comment was being received the committee and staff felt the public review period could have been better advertised. The committee expressed interest in extending the public comment period.

Staff are looking for approval of the evaluation report/review document for Willapa Bay Policy C-3622 from the full Commission and discussed the presentation overview for Saturday.

Commissioner Anderson discussed proposing a Blue Sheet on pinniped conservation and management. The initial briefing will be at the December Commission meeting. The long-term intent is to develop a management action plan.

**Habitat Committee**

**Commissioners in attendance: Smith, Kehoe, Baker, Linville, Anderson**

Commissioner Smith reported that the committee discussed the current riparian habitats in the 5 regions, the Shrub Steppe habitat that Washington recently lost due to the recent fires and received an update on the efforts with the Puget Sound nearshore habitat and the Co-Manager Habitat Workplan.

The committee also discussed no regret renewable energy and had a dialogue about across disciplines with the key idea being that habitat and conservation are integrated in all aspects of fish and wildlife management. Commissioner Kehoe noted that the Governor's office and the legislature are developing a Riparian Habitat policy and the department is part of those talks.

**Big Tent Committee**

Commissioner Baker reported that the committee met and discussed the strategic plan. The committee asked the staff to run them through where the plan currently is and update them on

outreach efforts, specifically to rural and northeast Washington, as well as, the morals and values embedded in the plan. The plan is scheduled to be adopted in October.

## **5. Climate Change – Briefing**

Lynn Helbrecht, Climate Change Coordinator and Jeff Davis, Conservation Director briefed the Commission on the agency efforts to combat climate change.

Commissioners Smith and Baker agree to aggressively move forward with the development of the steering committee and identification of stakeholders.

In the near future the Big Tent Committee will discuss a Commission policy on climate change.

## **6. Strategic Plan – Briefing, Public Hearing**

Jeff Davis, Conservation Director and Rob Geddis, Lean Performance Manager briefed the

Commission on the current status of the strategic plan.

**7. Columbia River Salmon Fishery Policy (C-3620) – Decision**

Bill Tweit, Special Assistant to the Director and Ryan Lothrop, Columbia River Fisheries Manager provided material to the Commission for a decision on the final revised draft language within Policy C-3620.

**Commissioner McIsaac made a motion, seconded by Commissioner Kehoe to adopt the public review draft containing revisions to Policy C-3620, as modified by the [red font language changes](#) brought forward at the September 1 Commission workshop and contained in the third of the agenda materials on the website for this agenda item.**

**Commissioner Graybill made a motion, seconded by Commissioner Thorburn to amend the motion in accordance with the changes shown in his [red font language changes version](#) brought forward at the September 1 Commission workshop and contained in the third of the agenda materials on the website for this agenda item. Commissioner McIsaac opposed. Commissioners Baker, Carpenter, Graybill, Smith, Kehoe, Anderson, Linville, and Thorburn approved. Motion passed with an 8/1 vote.**

**The amended main motion passed with a 5-4 vote. Commissioners McIsaac, Kehoe, Anderson, Linville and Thorburn approved. Commissioners Baker, Carpenter, Graybill, and Smith opposed.**

**8. North Cascades Elk – Briefing, Public Comment**

Brendan Brokes, Region 4, Director and Fenner Yarborough, Region 4, Wildlife Manager briefed the Commission on the current status of the North Cascades Elk Herd.

**9. Evaluation of Selective Harvest Experimental Salmon Trap in the Lower Columbia River – Briefing**

**11. Hatchery Policy (C-3619) Review – Briefing, Public Comment**

Ron Warren, Director of Fish Policy briefed the Commission on the public comment received during the public review of the proposed draft policy language within Policy C-3619.

The Commission and staff proposed the follow modifications to the timeline.

- Extend public comment to October 12
- Have the Fish Committee writing group develop draft language revisions
- At Oct 22-24 FWC meeting discuss public comment; approve draft revisions and/or provide direction to develop language changes
- Show draft language revisions to Co-Managers in mid-Nov
- Post draft language revisions for public review
- Final Commission public hearing and final decision at Dec 3-5 Commission meeting

**12. Commercial Whale Watching – Briefing**

Dr. Julie Watson, Killer Whale Policy Lead briefed the Commission on the agency’s work to develop a licensing program for commercial whale watching and rules regarding commercial viewing of Southern Resident Killer Whales.

**13. Willapa Bay Salmon Management Policy (C-3622) Comprehensive Review – Briefing, Public Comment**

Chad Herring, South Coast Fishery Policy Analyst briefed the Commission on the draft comprehensive review for Policy C-3622.

Chair Carpenter challenged the advisory groups to work together.

Commissioner McIsaac noted that the report is the kind of document the Commission had asked for and had some suggestions for section 1.7 called “Conclusions” addressing whether the purpose and objectives of the policy were achieved. He also asked that the public and Irene Martin’s comments on the draft report be addressed and recommended consider it being approved at the next meeting. He noted the Commission has yet to decide whether revisions to the policy will be made and asked that notice of this upcoming decision be made so the public has time to provide their input.

**14. Miscellaneous and Meeting Debrief**

Joe Panesko updated the Commission on the Fish Wildlife and Parks Division within the Attorney General’s Office, with the retirement of our division chief Joe Shorin, has merged into

the former Resources Division which advises DNR. We have a new division name and a new division chief, but WDFW's legal representation will remain pretty much unchanged.

Commissioner McIsaac discussed next steps for the Columbia River policy. First is to have staff convert motion documents into a formal policy document. He also spoke to a communications plan on the Commission decision that would include a prompt news release and a decision document that presented the rationale and justification for the final policy decision. The Commission discussed the news release and decision document and decided to move forward with both. Commissioner McIsaac also spoke to a [climate change amendment](#) for the Columbia River policy that was in the Commission materials but not brought on the floor for a vote. Commissioner McIsaac asks that it be considered in the future.

Commissioner Kehoe requested that a letter be sent to the Oregon Commission letting them know of the Washington decision and to request a meeting to discuss a plan to move forward towards policy concurrency. It was suggested that a small group of 4 Commissioners and key staff meeting with the Oregon commission in the future. The Commissioners supported the letter and a small group meeting. Commissioner Kehoe offered to compose the draft of the letter to be reviewed by the Commission before sent to the Oregon Commission.

**Commissioner Anderson made a motion, seconded by Commissioner Graybill, to bring forth a blue sheet briefing on pinniped conservation and management off the coast and the Columbia River. All in favor. Motion passes.**

#### **15. Executive Session**

Pursuant to RCW 42.30.110, the Commission met in executive session. No action was taken during executive session and the public was not permitted to attend.

Chair Carpenter adjourned the meeting at 3:30 p.m.
