We are proposed to classify the Oregon Vesper Sparrow as Endangered in the state of Washington under WAC 220-610-010. The estimated population of Oregon Vesper Sparrows in Washington is approximately 300 birds, with most (~75%) of them on a single site, JBLM's 91st Division Prairie. There have been several recent local extirpations at sites that supported a few pairs, the remaining sites with a few pairs are at great risk, and there has been no recent establishment of populations at sites with remnant prairie or savannah or with ongoing restoration.

The factors of habitat loss and degradation that historically precipitated population declines continue, but populations are now likely affected by demographic and genetic factors related to their small numbers (e.g., isolation of subpopulations, reduced genetic variability, and greater susceptibility to stochastic events). Nest predation has a greater impact in fragmented habitat, and seeds coated with neonicotinoid pesticides may be affecting Washington birds during migration and at wintering sites. Land use and disturbance activities are variable and sometimes intense during the breeding season depending on the

site; thus, potentially negatively affecting reproductive success and putting small populations at extreme risk of extirpation.

Research recently initiated on limiting factors will provide essential direction for appropriate conservation actions. However, given the extremely small population size in Washington, the predominance of that population at one location, the many recent local extirpations or near-extirpations, and a variety of habitat, disturbance, and potentially demographic factors that continue to negatively affect them, it is recommended that Oregon Vesper Sparrow be classified as an endangered species in Washington.

Washington's population of about 300 individuals is found primarily at sites in Thurston and Pierce counties with a few more numbering only in the dozens estimated for both San Juan Island and islands in the lower Columbia River. The birds once occupied breeding locations dispersed widely from southwestern British Columbia and the San Juan Islands through the southern Puget lowlands.

Few breeding populations remain but are found in Mason, Thurston, Pierce, and San Juan Counties. Historically breeding populations also occurred in Clallam County. Miscellaneous records have also documented non breeding individuals in Wahkiakum, Cowlitz, Clark, Skamania, King, Snohomish, Skagit, Island, Whatcom, and Grays Harbor Counties.

There is no direct effect on the Oregon Vesper Sparrow population, as this action is necessary to move towards recovering the species' populations. The Washington Department of Fish and Wildlife bases its proposal to classify Oregon Vesper Sparrow as endangered on scientific information contained in its report *Washington State Status Report for the Oregon Vesper Sparrow*. This report summarizes evidence that the Oregon Vesper Sparrow population is declining and is seriously threatened with extinction throughout its range in the state. The report recommends that the species be classified as an endangered species. The species has declined to the point that local populations are now only around 300 birds.

Protective measures will remain in effect for Oregon Vesper Sparrow in Washington if a listing of endangered is approved. The species would become listed under the state's list of endangered species and is protected from "take", which includes hunting, fishing, and harassment.

Under Washington state law (WAC 220-610-110), Oregon Vesper Sparrows are currently protected wildlife. RCW 77.15.130 outlines that protected wildlife shall not be hunted, taken, or harassed nor shall their eggs or nests. Oregon Vesper Sparrows would also remain on the list of Priority Habitats and Species (PHS).
