The Colockum Restoration Thin Phase 1 project is intended to improve ecological integrity ratings, habitat for multiple wildlife species, and forest health on the Colockum Wildlife Area.

Approximately 863 acres of overstocked forest stands on 6 units will be commercially thinned to more closely reflect the historic range of variability found in fire dependent forests before 1880. This will include a reduction in stocking levels to approximately 25 trees per acre on drier sites to 45 trees per acre in areas with more available moisture (north slopes, protected draws, etc.). All of the commercial thinning units will be a combination of leave tree marked with orange paint, or an operator select written prescription using the following criteria:

In all units, the thinning prescription will use a combination of Individual, Clumps and Openings (ICO) techniques and stocking/spacing strategies. The following criteria will be used during the leave tree selection process:

- Species preference, in declining order: western larch, ponderosa pine, Douglas-fir and grand fir.
- Leave "unique" species that are limited to microsites in the stand.
- > All hardwoods species will be automatic leave trees and will not be marked with paint.
- Leave trees with good growing characteristics (good crown ratios and relatively free of pathogens and/or insect damage).
- ➤ Leave defective trees with unique characteristics (trees with cat faces, "wolfy" crowns, large limbs, etc.) for Wildlife Reserve Tree (WRT) recruitment.
- ➢ In general, attempt to leave a residual stand with a post-treatment stocking level of between 25 (average 42' spacing) and 45 (average 31' spacing) trees/acre. Realize that these stocking/spacing guidelines are only intended as a spatial reference starting point. Residual tree density will adapt to account for changes in timber types and microsite conditions.
- In dry ponderosa pine timber types (ridgetops and south facing slopes), the residual tree target shall be between 15 and 30 trees/acre.
- > In dry mixed conifer timber types (north facing slopes and protected draws), the residual tree target shall be between 30 and 45 trees/acre.
- For type NS riparian areas (30' ELZ's), increase the leave tree density to approximately 40 TPA.
- > Scatter tree clumps (2 to 10 trees per clump) across the unit (e.g. desirable tree species, legacy trees, unique trees, etc.) where appropriate.
- ➤ Approximately 10% of each unit has been bounded out from the treatment area as skips that will not be treated, and will provide dense clumps for various wildlife species. These skips are distributed throughout each unit, range in size from 1 10 acres, and have been flagged out and completely excluded from the treatment prescription.

- Create small openings (0.5 to 3.0 acre) across the unit where appropriate. Take advantage of pre-existing openings with good production of browse species where appropriate.
- Minimum diameter for leave trees is 6" diameter at breast height (dbh).
- ➤ In general, leave trees >28" dbh unless they pose a safety threat (e. g. tree is at risk of falling over a main line road) or they are a non-preferred species with preferred species surrounding (e.g. grand fir surrounded by ponderosa pine, western larch or Douglas-fir).
- Existing snags will not be marked as leave trees with orange paint. All snags that do not pose a safety threat, as per L & I guidelines, are required to be left by the logging contractor. Those snags dropped for safety reasons by the logging contractor will be left in place. Trees marked with two orange bands will be operator created snags and cut as high as safely possible above the ground.
- Dwarf mistletoe infected trees provide important habitat to a variety of wildlife species and will be left individually or in clumps strategically across the unit (lower hillside, adjacent to non-impacted tree species, draw bottoms, etc.). The goal is to provide habitat benefits from dwarf mistletoe infected trees while minimizing impacts to other leave trees in the unit.

Additional elements of this proposal may include:

- Slash disposal where debris from timber harvest operations (limbs, tops, etc.) will be piled and trailed at landings in preparation for burning. Slash burning will be carried out after the timber harvest work has been completed. All slash burning will be completed as per Department of Natural Resources and Department of Ecology regulations.
- Pre-Commercial Thinning/Slashing: The variable density harvest units will be re-evaluated after harvest operations have been completed to assess the need for pre-commercial thinning and/or slashing.
- Close and/or abandon selected roads, at the discretion of the local Wildlife Area Manager, after project completion.
- Prescribed broadcast fire in selected units dependent upon management needs and available funding.

The goal of future treatments will be to continue restoring forest stand structure and species composition within the historic range of conditions found on these sites before 1880, when natural disturbance regimes like frequent, low-severity wildfire were the primary ecological process.

As part of this proposal, 31,845 feet of new road will be constructed. Approximately 90% of these roads are utilizing existing surfaces that were constructed when these stands were harvested previously. These roads will be abandoned to Washington Forest Practice standards after completion of thinning activities, unless road access is needed for prescribed burning purposes beyond this date. This work will include installing undrivable water bars, spreading slash and debris over the road prism, and grass seeding with a mix of native species.

The Colockum Restoration Thin Phase 1 project is located approximately 15 miles south of Malaga, WA. It is part of the WDFW Colockum Wildlife Area in Kittitas County. The units are located in parts of Sections 1, 12 & 13, Township 20 North, Range 20 East, and Sections 7 & 9, Township 20 North, Range 21 East, WM. See attached project map for the location of individual units.

Soils found on these units are generally loams, ranging from sandy to cobbly to stony. These soils are well drained with a moderate potential for erosion. These soil types support mixed conifer forests, bitterbrush and bluebunch wheatgrass.

Minor erosion could occur from harvesting equipment and skidders operating in the

project area. There may also be minor erosion from roads and right-of-ways due to increased log truck traffic. If erosion does occur, mitigation measures including installation of straw bales, straw waddles, water bars, drain dips and grass seeding will be used as necessary. Additionally, logging operations and/or log hauling will be curtailed until mitigation measures are in place and the erosion threat has subsided.

 - Ground based equipment will not be allowed on continuous slopes in excess of 45%. Any equipment on steeper slopes will be tethered and/or cable assisted.
 - Skid trails on steeper slopes will be water barred appropriately following skidding operations as per written instruction and approval of completed work from the WDFW Contract Administrator
 - At the discretion of the WDFW Contract Administrator, exposed skid trails on steeper slopes will be grass seeded with certified weed free seed as per Wildlife Area Manager recommendations and approval of completed work from the WDFW Contract Administrator
 - Exposed cut banks resulting from road building and/or maintenance activities will be grass seeded with certified weed free seed as per Wildlife Area Manager recommendations and approval of completed work from the WDFW Contract Administrator
 - Drain dips and/or water bars will be installed on steeper roads post-harvest as per written instruction and approval of completed work from the WDFW Contract Administrator
 - Temporary roads necessary for log hauling operations will be abandoned at the discretion of the Wildlife Area Manager. Road abandonment must be approved in writing by WDFW Contract Administrator
 - Haul operations will be suspended immediately, until mitigation is approved in writing by the WDFW Contract Administrator, if any delivery to typed waters is observed

The proposal will result in a temporary increase in vehicle emissions from logging equipment and log trucks. There should be no significant impact to air quality. Slash burning and potential prescribed broadcast burning will be conducted in accordance with provisions contained in the DNR slash burning permit as well as any smoke management, Department of Ecology and local fire district regulations.

The North and South Forks of Colockum Creek are year-round streams that are located in the immediate vicinity of the site, and they eventually flow into the Columbia River. All seasonal streams flow for brief periods during snowmelt and high precipitation events.

There are plans to abandon an existing drivable ford on the South Fork Colockum Creek in Section 6 of Township 20 North, Range 21 East. This work will take place after all harvest operations and potential prescribed fire activities are complete. This project will be permitted under its own distinct Forest Practice Application with the Washington Department of Natural Resources.

Spring runoff from snow melt and rainfall runoff could occur on the forest floor, roads and landings. Water will be dispersed back into undisturbed forest areas for natural filtration through vegetation and soil. Runoff intercepted by roads and ditches will be diverted through existing culverts, water bars, drain dips and ditches to the forest floor. If the event of an extreme weather event, runoff could reach nearby streams.

2) Could waste materials enter ground or surface waters? If so, generally describe.

There is the remote chance that fuel or oil associated with equipment operations could be spilled and potentially enter ground or surface waters. The contractor will be required to have an approved spill kit in each piece of equipment to contain and clean up spills if they should occur. Fuel storage is only allowed in approved areas. The contractor will be required to contact the WDFW Contract Administrator and the appropriate Department of Ecology Office immediately after a spill occurs.

However, equipment will be required to have spark arrestors to reduce the fire risk. In addition, the contractor will be required to monitor and adhere to Industrial Fire Precaution Level (IFPL) regulations as required by the Washington State Department of Natural Resources. Burning of slash piles, resulting in temporary smoke emissions, could occur after harvest operations are completed. Additional temporary smoke emissions could be possible if prescribed fire is used as a management tool post treatment.
