Hello Garret, Evan and Derek,

Thank you for Dept. of Ecology's comments on the Stillman Creek Restoration project in Lewis County, WA. Below is a response to those comments by topic.

Solid Waste Management – Fill material for the project is limited to wood and rock necessary to build the large wood structures. Excavated material consists of deposited river sediment and riparian soils and will be disposed of at an appropriate off-site facility. These provisions are included in the project bid package that is currently under review at WDFW.

Water Quality/Watershed Resource Unit – Erosion and sediment control BMPs will be installed and maintained prior to, during and immediately following construction for the duration of the project. This requirement is typically written into our Corps issued NWP and WDFW issued HPA. WDFW is aware that a stormwater construction permit is required for the project and additional requirements may be necessary for work in impaired waters. We will work with the selected contractor to apply for and implement the requirements of the permit.
