**ADDENDUM 22-029 TO DETERMINATION OF NONSIGNIFICANCE (DNS) 99-010  
DATED: MARCH 3, 1999**

**Original Name of Proposal:** MONTROIX – GRASS CARP – LAKES 1, 2, AND 3

**Description of Addendum 22-029:**

The Environmental Checklist for the original DNS indicated that the planting of grass carp was a one-time event, in 1999. Now the project proponents are requesting to restock grass carp. Restocking would occur as fish die due to predation or natural die off. Current WDFW Grass Carp Policy (POL 5103) limits restocking to 5-year intervals, with the intent to not overstock the pond or lake.

This Addendum adds restocking to the original proposal and SEPA determination, as well as updates the project proponent and corrects spelling errors. Also see map of area that was not in original proposal.

The original project and other elements of the proposed work have been modified as indicated below in underlined red font.

**Corrected Name of Proposal:** MONTREUX GRASS CARP – LAKES 1, 2, AND 3

**Description of Original Proposal:**

Plant triploid (sterile) grass carp into Lakes 1, 2, and 3, with no public access, to control aquatic vegetation. Future restocking may be necessary due to fish loss.
