DETERMINATION OF NONSIGNIFICANCE (DNS) AND ADOPTION OF EXISTING ENVIRONMENTAL DOCUMENT (ENVIRONMENTAL ASSESSMENT)

Name of Proposal: DNS/Adoption 22-028: TWISP RIVER AND LITTLE BRIDGE CREEK

AQUATIC RESTORATION

Description of Proposal:

The Yakama Nation proposes to conduct restoration activities to enhance adult spawning and juvenile rearing habitat for ESA-listed endangered Upper Columbia spring Chinook Salmon (*Oncorhynchus tshawytscha*) and threatened Columbia River summer steelhead (*Oncorhynchus mykiss*).

This proposal applies to three distinct project areas: Mystery Reach, War Creek Reach and Lower Little Bridge Creek. All three project areas are in close proximity to each other – within the Twisp River watershed and solely located on Wenatchee National Forest property. The objective of this large scale restoration effort is to restore natural riverine processes which create and maintain high quality fish habitat, through large wood supplementation.

Throughout the three project areas; 1,080 logs with rootwads attached will be installed and 32 native spruce trees will be felled in approximately 3.5 miles of stream channel. Accumulations of large wood will be sized to mimic natural accumulations that are appropriate for the size of the stream. The Mystery Reach Project Area is on the mainstem Twisp River (rivermile 21-23), so large wood accumulations will consist of 10-60 individual pieces of large wood. One structure, near the staging area, will be constructed with pilings and bank burial using an excavator. Twenty-seven additional structures will be constructed by a heavy-lift helicopter. A construction oversight engineer will be present to direct large wood placement throughout construction of all three project areas.

The War Creek Reach Project Area is also located on the mainstem Twisp River between rivermile 17 and 18. A helicopter will be used to construct approximately 16 large wood structures. However, we will access eight of those with an excavator to drive vertical wooden pilings to increase stability. These ballasted structures are situated to retain alluvial wood and bedload within the project area and on National Forest property, in an effort to avoid impacts to private lands downstream. Each structures will consist of 9-18 pieces of large wood and a total of 60 pilings will be installed.

The Lower Little Bridge Creek Project Area is located on a significant tributary (average wetted width 20') to the Twisp River. Naturally recruited whole trees tend to have a long residence time due to the lack of sufficient hydraulic power to transport them downstream. Therefor large wood accumulations are smaller generally consisting of less than 5 trees each. The large wood for this project will be solely placed via the helicopter.

WDFW has made a determination of Non-Significance, and is adopting a NEPA Environmental Assessment and incorporating another document by reference under SEPA rules.
