We are proposing to downlist and reclassify the American White Pelican in the state of Washington under WAC 220-200-100. Anticipated effects include recognizing the progress towards recovery of the species and a decline in conservation concern and prioritization. However the species will still be classified under RCW 77.15.130 offering continued protections from malicious take or harassment.

The Washington Department of Fish and Wildlife bases its proposal downlist American White Pelican from Threatened to Sensitive on scientific information contained in its report *Washington State Periodic Status Review for the American White Pelican*. This report summarizes evidence that the American White Pelican population is robust and no longer meets the definition of Threatened in the state. However there is still existing concern around the single consistent nesting colony in the state and its vulnerability to disturbance. The report recommends that the species be reclassified as a Sensitive species.

The western population of white pelicans has recovered substantially, and given the size of the Badger Island colony and number of non-breeding white pelicans in Washington during the past several years, a change in listing is being considered. The species remains somewhat vulnerable, however, as only the single colony regularly forms in Washington, and white pelican colonies are highly sensitive to disturbances; adults will desert and/or leave eggs and young exposed to predation following disturbances. A Sensitive species is, "vulnerable or declining and is likely to become endangered or threatened in a significant portion of its range within the state without cooperative management or removal of threats" (WAC 220-610-110).

In Washington, American White Pelicans are overwinter along the major rivers in the Columbia Basin, nesting colonies are found on Badger Island in the Columbia River in Walla Walla County and sporadically in Padilla Bay in Skagit County. Affected counties include Skagit, Walla Walla, Franklin, Benton, Yakima, Klickitat, Skamania, Clark, Cowlitz, Wahkiakum, and Pacific.

The Washington Department of Fish and Wildlife bases its proposal to reclassify American White Pelican as sensitive on scientific information contained in its report *Washington State Periodic Status Review for the American White Pelican*. This report summarizes evidence that the American White Pelican population no longer meets the definition of Threatened in the state. However there is still existing concern around the single consistent nesting colony in the state and its vulnerability to disturbance. The report recommends that the species be reclassified as a Sensitive species.

Protective measures will remain in effect for American White Pelican in Washington if a downlisting to sensitive is approved. The species is protected malicious and intentional harassment.

RCW 77.15.130 outlines that Sensitive wildlife shall not be hunted, taken, or harassed nor shall their eggs or nests. American White Pelican would also remain on the list of Priority Habitats and Species (PHS).
