#### Specific Problem or Need

#### What is the business need or problem that requires this contract?

This contract will help WDFW achieve existing priorities and strategies, including WDFW's 25-Year Strategic Plan and WSDOT's Secretary's Executive Order #E 1031.02.10. Further, it will bring Washington State into the fold of other western states working to conserve and enhance connectivity through similar strategies.

#### Sole Source Criteria

Describe the unique features, qualifications, abilities or expertise of the contractor proposed for this sole source contract.

The contractor is uniquely qualified to modify TerrAdapt to better suit agency needs because they are the sole developer of this software and the source code is not publicly available. The contractor also has a highly qualified staff with a unique combination of skills in Google Earth Engine, Google cloud computing, remote sensing, and ecological modeling. There is no other vender able to provide the capabilities of the TerrAdapt software, nor do they possess the contractor's unique skillset to modify it to better meet agency needs.

TerrAdapt is a first-of-its-kind dynamic conservation planning tool that leverages the power of Google Earth Engine and the Google Cloud to monitor landscape change over time, project future threats from climate change, and prioritize areas for actions to mitigate risks. At this time, there is no alternative to this novel product in our region, and the contractor is the only vendor with access to source code and the skillset required to modify TerrAdapt to meet agency needs.

### What considerations were given to providing opportunities in this contract for small business, including but not limited to unbundling the goods and/or services acquired.

Internet searches with key word search phrases were used to identify whether small businesses with the necessary skillset and proprietary software were able to complete this task. These searches did not identify any small businesses who would be able to perform the required services (either in their entirety or if services were unbundled).

By contracting with this contractor, WDFW avoids replicating the cost (est. more than \$1M) and considerable time (est. several years) required to develop the remote sensing and Google earth engine and software development skills required to replicate the capabilities of TerrAdapt within the agency. Even if the agency did invest to develop this capability internally, there is considerable risk that it could not assemble the required technical skills to develop this ambitious software. These costs and risks are mitigated by contracting with the contractor, which has a proven track-record of developing this software and modifying it to meet user needs.

WDFW provides technical assistance, permitting, research and planning support to abroad array of stakeholders across the state, with the goal of ensuring industry, infrastructure, recreation, agriculture, forestry and other human activities are compatible with healthy fish and wildlife populations. This includes guidance for managing our state's infrastructure, lands and waters to protect fish and wildlife habitat, restoring habitat, as well as research and planning to support management of game species and recovery of at-risk species. Many of WDFW's technical assistance, permitting, research and planning activities are based on best practices derived from many decades of past experience. However, those practices were developed in an historical climate that is now changing rapidly. These shifting baselines and the high uncertainty around future conditions are making it increasingly challenging to provide effective guidance to stakeholders. Not having this sole source filing approved will make it challenging for WDFW to continuing to uffiling its mission to "preserve, protect, and perpetuate fish, wildlife, and ecosystems while providing sustainable fish and wildlife recreational and commercial opportunities." The agency is already experiencing climate-related impacts, which will be exacerbated as the pace of climate change accelerates over the coming decades. This sole source filing will help WDFW prepare and adaptively manage for the impacts of climate change across the agency's programs, plans, and projects.
