

Catch Sharing Plan

Management Goals

- 1. Establish season structures for each subarea that maximize fishing opportunity and achieve but not exceed subarea quotas.
- 2. Flexibility through timely inseason action(s), such as opening additional fishing days or shifting quotas between subareas, may be necessary to achieve the overall Washington sport allocation and fishery objectives.

2022 Catch Sharing Plan

Objectives


All Sub-areas


- Season dates will be developed at the end of November each year for the following year
- Open up to 3 days per week April, May, June; may include at least one weekday and one weekend day
- If quota remains after final open day in June, additional openings may be implemented in August and September

Sub-area specific


- Puget Sound earliest date to open April 1
- Coastal subareas earliest date to open April 30
- Columbia River season dates coordinated with Oregon, no Saturdays
- Columbia River Nearshore open Monday Wednesday following opening of the alldepth fishery through September 30 or until 500 lb. quota attained
- South Coast Nearshore May open if balance of primary fishery quota is insufficient for a full fishing day, open first Saturday after closure of primary fishery, seven days per week until quota taken

WDFW Season Setting Principles

- Avoid effort shift: continue to align fishing days as much as possible, particularly Columbia River/ South Coast and North Coast/Sekiu to maximize season length and fishing opportunity
- Provide advance notice of season dates to allow anglers to plan rather than add dates inseason
- Provide more fishing opportunity in areas where catch was below the subarea allocation
- Recognize traditional days if possible (e.g., North Coast: Thu/Sat, South Coast: Sun/Thu, MA 5: Memorial Day derby)

- North Coast and Columbia River Status Quo

Proposal for Discussion Coast

Marine Area 1:

May 4 through May 21: 2-days per week, Thursday, and Sunday

Memorial Day weekend: Thursday, May 25

June 1 through June 25: 2-days per week, Thursday and Sunday, and Thursday, June 29

Marine Area 2:

May 4 – 21: 3 days per week, Tuesday, Thursday, Sunday, and Tuesday, May 30

If sufficient quota remains: June 15, 18 (Thursday, Sunday) and June 22, 25 (Thursday, Sunday)

Marine 3 and 4:

May 4 through May 21: 2-days per week, Thursday, and Saturday

Memorial Day weekend: Friday, May 26 and Sunday, May 28

June 1 through June 24: 2-days per week, Thursday and Saturday, and Thursday, June 29

All Areas:

If quota remains after June 30, consider August and September dates.

Proposal for Discussion Puget Sound

Marine Area 5, 6-10

Open all areas at the same time.

April 6 through May 22: 5-days per week, Thursday-Monday

Memorial Day weekend: Friday through Sunday, May 26, 27, 28

June 1 through June 30: 7-days per week

If quota remains after June 30, consider August and September dates

Puget Sound: Recommend a **7-days a week beginning in mid-April**. This would allow anglers to fish on the best weather days and avoid days with bad weather/unsafe conditions. Because the sport harvest quota has gone unfilled in recent years, there is no reason to restrict access to this fishery to preserve quota to prolong the season. Extending the halibut season into August and September does not provide a good opportunity to increase sport harvest of halibut in Puget Sound due to the increased activity/abundance of dogfish during the warmer periods. Finally, trading unused halibut sport quota from Puget Sound to coastal areas unfairly shifts opportunity away from fishers who live in or prefer to fish in the more protected Puget Sound areas. This trading of quota also favors coastal charter operators over Puget Sound private boat anglers.

Allowable bait: The bottom fish/halibut regulations should be amended to **allow for use of sand dabs as** halibut bait in waters greater than 120 feet deep in Puget Sound. There is no conservation reason (i.e., reduced potential bycatch of rockfish) to prohibit possession/use of sand dabs as bait for halibut in Puget Sound.

Puget Sound

- · Open MA 5, 6-10 in April
- Five or seven days per week

• Coast:

- South Coast: three days per week in May, four additional days noticed in June
- · North Coast and Columbia River: status quo

All Areas:

· Option for seven days per week in August and September
