## **DETERMINATION OF NONSIGNIFICANCE (DNS)**

Name of Proposal: DNS 23-008: KLICKITAT WILDLIFE AREA – SIMCOE MOUNTAINS

UNIT BOUNDARY/INTERIOR FENCE

## **Description of Proposal:**

Project is to install 24,866 linear feet of fence and a new cattleguard. New fence will be 4-wire fencing. Some of the fencing replaces old fence, and some is new boundary fence that will aid to control grazing cattle movement. All current access points on the Yakima Nation Property Boundary will remain outside the new fence, so that no current access points are affected by this project. Fencing will conform to NRCS standards regarding construction of end braces and H-Braces, with steel posts on regular spacings.

**Location of Proposal, including street, if any:** North and south of Box Spring Road within the Simcoe Mountains Unit of the WDFW Klickitat Wildlife Area, approximately 9 miles west of Bickleton, Klickitat County, Washington:

- Township 6N, Range 18E, Sections 24 and 25
- Township 6N, Range 19E, Sections 19 and 30

**Lead Agency:** Washington Department of Fish and Wildlife (WDFW)

WDFW has determined that this proposal will likely not have a significant adverse impact on the environment. Therefore, state law<sup>1</sup> does not require an environmental impact statement (EIS). WDFW made this determination of nonsignificance (DNS) after we reviewed the environmental checklist and other information on file with us.

We issued this DNS according to state rules.<sup>2</sup> We will not act on this proposal for 14 days from the date we issued the DNS. Agencies, tribes, and members of the public are invited to comment on this proposal or DNS. We must receive your comments within 14 days of the date of this letter. The comment period will end at 5:00 pm on March 8, 2023.
