# 11. Petitions: Spring Bear and Black Bear Timber Damage - Briefing, Decision

Anis Aoude, Big Game Manager briefed the Commission and asked for a decision on three petitions that request the Commission to:

- "immediately begin Rule Making for the 2024 and future year(s) Spring Black Bear Management Hunts".
- "immediately begin Rule Making for the 2023 Spring Black Bear Hunting on Public Lands using the same science, metrics, benchmarks and thresholds used in the Spring Black Bear Timber Damage Program (aka Spring Black Bear Hunts on Private Land)"
- "immediately begin Rule Making for the 2023 Spring Black Bear Hunts for the protection Ungulate Neonates from Black Bear Predation, Spring Black Bear Timber Damage on Public Lands and the protection of Humans, Pets and Property from Black Bear Conflict".

Commissioner Ragen made a motion, seconded by Commissioner Lehmkuhl, to deny the petitions as presented by staff. All in favor. Motion passes.
