




Management Overview Catch Sharing Plan (CSP)

- PFMC document
- Guides tribal, non-tribal commercial and recreational fisheries off WA, OR, and CA.
- Framework for allocating Area 2A allowable catch (FCEY) to subareas
- Framework implemented in federal rule
- Updated annually

Management Overview WA Catch Sharing Plan Goals

Catch Sharing Plan management goals relevant to WA recreational fishing include:

- 1. Establish season structures for each subarea that maximize fishing opportunity and achieve but not exceed subarea quotas.
- 2. Flexibility through timely inseason action(s), such as opening additional fishing days or shifting quotas between subareas, may be necessary to achieve the overall Washington sport allocation and fishery objectives.

Management Overview WA Catch Sharing Plan Objectives

All Sub-areas

- Season dates will be developed by the end of November each year for the following year
- If quota remains after final open day in June, additional openings may be implemented in August and September
- Open up to 7-days/week in August and September


Sub-area specific

- Puget Sound earliest date to open April 1; up to 5-days/week April and May, up to 7-days
 per week in June
- Coastal subareas earliest date to open April 30; up to 3-days/week April, May, June
- South Coast Nearshore May open if balance of primary fishery quota is insufficient for a full fishing day, open first Saturday after closure of primary fishery, seven days per week until quota taken
- Columbia River season dates coordinated with Oregon, no Saturdays, up to 3-days per week April, May, June
 - Columbia River Nearshore open Monday-Wednesday following opening of the alldepth fishery through September 30 or until 500 lb. quota attained

Management Overview WDFW Season Setting Principles


- Avoid effort shift to maximize season length and fishing opportunity -Continue to align fishing days as much as possible, particularly Columbia River/ South Coast and North Coast/Sekiu
- Provide advance notice of season dates to allow anglers to plan rather than add dates inseason
- Provide more fishing opportunity in areas where catch was below the subarea allocation
- Recognize traditional days if possible (e.g., North Coast: Thu/Sat, South Coast: Sun/Tue, MA 5: Memorial Day derby)

Management Overview Halibut Management Timeline



WA Halibut Season - 2023

- Puget Sound Front loaded spring compared to previous years
- Aligned Area 5 with Puget Sound
- South Coast Added 3rd day per week in May
- North Coast Status quo to start
- Columbia River Status quo to start
- Flexible inseason Added June dates, Adding dates in August and September, Sharing statewide quota

Puget Sound

- Opened Thursday, April 6
- 5 days per week, April and May, Thursday Monday (compared to 3 days/week in 2022)
- 7 days per week, June 1-30 (compared to 3 days/week in 2022)

Area 5 – Sekiu

• Aligned season with Puget Sound instead of North Coast (Area 3 and 4)

North Coast

- Opened May 4, 2-days per week, Thursday and Saturday except Friday and Sunday of Memorial Day weekend
- Inseason action: Added Friday and Sunday; 4-day per week, Thursday-Sunday schedule in June

South Coast

- Opened May 4, 3-days per week, Tuesday, Thursday, Sunday
- Open four days in June: Thursday and Sunday, 15th, 18th, 22nd, 25th

Columbia River

- Opened May 4, 2-days per week, Thursday and Sunday, except no Sunday of Memorial Day weekend
- Open 2-days per week in June, Thursday and Sunday
- Inseason action: Added 2 days in June, Tuesday, 13th and 20th



Review 2023 Late Season Opportunity

Announced additional season dates July 24^{*}

Columbia River (Area 1)

Saturday and Sunday, August 26 and 27; Friday and Saturday September 8 and 9, and Friday September 22

Southern Near Shore Fishery (Area 1)

Through September 27; Monday through Wednesday

South Coast (Area 2)

Saturday and Sunday, August 26 and 27; Friday and Saturday September 8 and 9, and Friday September 22

North Coast (Areas 3 and 4)

August 17 through September 30, seven days per week

Puget Sound (Area 5 through 10)

August 17 through September 30, seven days per week

Increased annual limit to 6 fish

*All openings dependent on available quota

Ideas to Consider for 2024

Adopt dates through June in regulation!

Coastal areas (1-4)

May

- > Area 3-4: open five days/week, Thursday-Monday
- > Area 1: Memorial Day weekend dates
- > Area 1: Add Tuesdays, aligning with MA 2, = 3-days per week

June (see first point!)

- > Area 1: three days/week
- > Area 2: four or five days
- > Area 3-4: five or seven days/week

Straits and Puget Sound

- > Align Area 5 with Area 6-10
- > Areas 5-10: seven days/week in April
- Areas 5-10: five days/week in May
- > Areas 6-10: open in February, seven days/week

All Areas

August and September

- > Area 5-10: open when salmon closes, seven days/week
- Coastal areas: increase number of days

Keep in mind!

- Need to balance impacts to Yelloweye Rockfish
- Sampling Constraints
- NMFS regulatory schedule requirements
- Coordinate Columbia River with Oregon
- Area 1 Consider 1st directed halibut opener

Range of Options for 2024

Puget Sound (Marine Areas 5, 6-10)

<u>Status Quo:</u> Open April 4 through May 20 **five days per week**, Thursday through Monday. Memorial Day open Friday, May 24 through Sunday May 26. Open, May 30 through June 30, seven days per week. If quota remains, open up to seven days per week in August and September.

Option 1: Open April 4 through May 20, **seven days per week**. Memorial Day open Friday, May 24 through Sunday May 26. Open, May 30 through June 30, seven days per week. If quota remains, open up to seven days per week in August and September.

Option 2: Open starting in **February or March, seven days per week** through June 30. Memorial Day open Friday, May 24 through Sunday May 26. If quota remains, open up to seven days per week in August and September.

Range of Options for 2024

North Coast (Marine Areas 3 and 4)

<u>Status Quo:</u> Open May 2 through May 18, **two days per week**, Thursday and Saturday. Memorial Day weekend, open Friday and Sunday, May 24 and 26. May 30 through June 29, open **two days per week**, Thursday and Saturday. If quota remains, open up to seven days per week in August and September.

Option 1: Open May 2 through May 20, five days per week, Thursday through Monday. Memorial Day weekend, open Friday and Sunday, May 24 and 26. May 30 through June 29, open five days per week, Thursday through Monday. If quota remains, open up to seven days per week in August and September.

Range of Options for 2024

South Coast (Marine Area 2)

<u>Status Quo</u>: Open May 2 through May 21, **three days per week**, Thursday, Sunday, and Tuesday. Memorial Day weekend, open Thursday, May 23. If sufficient quota remains, open June 13, 16, 20, 23. If quota. If quota remains, open up to seven days per week in August and September.

<u>Option 1:</u> Open May 2 through May 21, **three days per week**, Thursday, Sunday, and Tuesday. Memorial Day weekend, open Thursday, May 23. If sufficient quota remains, open June 13, 16, **18**, 20, 23, **25**, **27**, 30. If quota remains, open up to seven days per week in August and September.

Columbia River (Marine Area 1)

<u>Status Quo:</u> Open May 2 through May 19, **two days per week**, Thursday and Sunday. Memorial Day weekend, open Thursday, May 23. Open May 30 through June 30, **two days per week**, Thursday and Sunday. If quota remains, open up to seven days per week in August and September.

Option 1: Open May 2 through May 21, three days per week, Thursday, Sunday, and Tuesday. Memorial Day weekend, open Thursday, May 23 and Sunday, May 26. May 30 through June 30, open three days per week, Thursday, Sunday, and Tuesday. If quota remains, open up to seven days per week in August and September.

Council Catch Sharing Plan Revisions – Two Processes

<u>Annual - Routine</u>

- Council considers recommendations from states on recreational season structure
- Council adopts incidental landing restrictions for salmon troll and commercial sablefish longline fisheries
- May consider other changes to CSP as needed


2022-2024 Review

- Separate action from annual season setting process
- Prompted by need to consider enforcement issues in commercial halibut fisheries and CA request for increased recreational quota
- June 2023 Council requested analysis and draft revisions to CSP
- September Council will consider a Range of Alternatives and Preliminary Preferred Alternative for public review
- March or April?

Update on PFMC Pacific Halibut Activity PFMC Catch Sharing Plan Review

Council request for proposed revisions and analyses, June 2023:

- Update or improvement where needed, management objectives in the CSP for each sector or sub-area with a specific allocation
- Request California review their fishery objectives to achieve a longer season (e.g., delay opening, open fewer days per week)
- Expand the CSP flexible inseason management provisions to allow transfer of projected unused quota between all WA, OR, and CA recreational sub-areas and commercial sectors after August 15.
- Move 0.5 percent of the WA sport allocation and 1.0 percent of the OR sport allocation to the California sport sector in years when:
 - a. Option 1: when the 2A FCEY is 1.5 million pounds or greater and,
 - b. Option 2: when the 2A FCEY is 1.3 million pounds or greater.
- Move 1 percent from the non-tribal WA sport allocation and 2 percent from the non-tribal OR sport allocation to the CA sport sector.
 - a. Option 1: when the 2A FCEY is 1.5 million pounds or greater and,
 - b. Option 2: when the 2A FCEY is 1.3 million pounds or greater.
- Regulatory changes as recommended by the Enforcement Consultants (Agenda Item E.1.a, <u>Supp EC Report 1</u>, June 2023).
