Rule changes to WAC 220-412-090 related to multi-season tags will be considered for amendment to create a subset of multi-season tags for this incentive program.

The Director has been given approval authority by the Fish and Wildlife Commission. The Director is scheduled to make a decision on October 25, 2023.

The Department leads the chronic wasting disease surveillance program which relies on voluntary submission of harvested deer and elk by hunters to have tested for CWD. To increase sample submission, we are proposing an incentive for hunters who submit a sample. Those that submit a sample are automatically entered into an exclusive drawing for one of 100 multi-season deer tags. This requires an amendment to WAC 220-412-090 to create a subset of multi-season tags.

Checklist questions contained within Section B [1-16] are not filled out because this is a statewide non-project rule making proposal that does not have impacts to environmental elements as described in Section B. Issuance of hunting licenses is exempt from SEPA under WAC 197-11-835(8).
