~50 public comments received

 Comments were compiled into single document posted with meeting materials for this agenda item

Comments spanned a wide range of topics



- Most frequent topics were specific season desires for fisheries
 - Specific opening and closing dates for specific areas
 - Open winter fisheries for blackmouth in areas currently closed
 - Schedule concurrent openings across Puget Sound
 - More non-selective fishing opportunity
 - Less non-selective fishing opporunity
 - These are the trade-offs and decisions we engage in annually during the North of Falcon process



- Avoid/reduce frequency of emergency closures
- Offer better marine fishing opportunity
- Prioritize extreme terminal and freshwater fishing opportunity
- Define meaningful recreational opportunity to prioritize maximizing harvest over length of opportunity



 Comments on allocation of ocean harvest between ocean areas, and allocation of ocean vs inside fishing opportunity

- Increase hatchery production
- Create new 'Bubble' fisheries

Support for addition of section on reporting



- Other concerns:
 - Commercial fisheries are allowed to occur
 - Transparency of meetings with tribal governments
 - Status of ESA-listed stocks is not improving
 - Climate change is not directly addressed in the policy
 - That any non-tribal fishing is allowed
 - That the policy does not give enough consideration to marine mammals, birds, beavers or other non-human fishers



- Some specific comments on policy language in several of the letters received (attachments in the public comment document)
 - Include gamefish in language when considering managing for recovery, offering opportunity on healthy stocks, and providing diverse opportunities within available stock impacts
 - Include a direct reference to the Puget Sound Salmon Management Plan in the list of guiding documents



- Specific language suggestions on in-season management, limits on fishery catch & encounters, and communications on those topics
- Language addition to Pacific Ocean section on prioritizing selective fisheries to harvest hatchery salmon and help meet conservation objectives for ESA-listed and weak stocks
- Language on Puget Sound management and prioritization of chum and pink opportunity
 - Re-insert language on minimizing gear conflicts
 - Delete language on expected relative catch proportions



Modifications in draft policy

- Redline version provided with summary sheet includes all modifications made to the expired policy as presented in December
- Re-inserted phrase "while minimizing gear and other fishery conflicts" into the guidance for providing fishing opportunity for Puget Sound-origin pink and chum salmon
