Filing Justification

Specific Problem or Need

What is the business need or problem that requires this contract?

Washington state faces a critical challenge related to habitat connectivity, and recently federal dollars are becoming available at a variety of agencies and opportunities. Conservation Northwest would assist in cataloging and strategizing around these opportunities, to assist WDFW and WSDOT to be more successful in maximizing opportunity to garner this funding.

CNW has been at the forefront of habitat connectivity efforts for the last 10 years, demonstrating leadership, credibility and expertise that is respected by WDFW, WSDOT, and the tribal partners and stakeholders seeking to implement Washington's Habitat Connectivity Action Plan. Their track record in leading similar projects makes them a suitable sole source vendor.

Unbundling was considered, but the tasks are interconnected and the overall dollar amount small.

- Technical Learning curve: It would take a new contractor a year or more to achieve mastery in both the technical aspects of Washington's connectivity strategy and rationale, as well as all the details of the existing and new federal programs that may contribute funding to this work. - Quantification of Risks: The risk of waiting to do this work is losing the time limited opportunity to successfully compete for tens of millions of federal connectivity funding that is available now.

We find ourselves in the last third of a significant federal funding round. Some funding windows are closing soon. Choosing CNW as a sole source vendor ensures timely execution and maximizes the impact of available resources.

Reasonableness of Cost

Since competition was not used as the means for procurement, how did the agency conclude that the costs, fees, or rates negotiated are fair and reasonable. The costs are on a reimbursable basis only, and were compared to state rates and work, and found reasonable. WDFW has evaluated the potential of creating a project-designated FTE within the agency to do this work. The scope of work is likely to warrant a Management Analyst 3 or 4 designation, for which the salary alone would fall between \$56,676 - \$88,416. Conservation Northwest is allocating their own resources to this effort as well, which means that WDFW receives the benefit of 1.0 FTE for the duration of the contract, for a fraction of the full cost.
