#### **DETERMINATION OF NONSIGNIFICANCE (DNS)**

Name of Proposal: DNS 24-026: RULE MAKING FOR CONSTRUCTION, CREATION,

AND MAINTENANCE OF ROADS, TRAILS, AND STRUCTURES

## **Description of Proposal:**

WDFW proposes to enact a new rule to protect natural, cultural, and tribal resources from damage by making the construction, creation, and maintenance of roads, trails, and structures illegal without written permission from the Washington Department of Fish and Wildlife. This will apply to all WDFW-managed lands in the state.

The majority of user-built routes (roads or trails) have not been approved by land managers and have not yet gone through the proper analyses to ensure they don't negatively impact natural or cultural resources or wildlife habitat. These trails usually do not meet land manager trail standards and can create safety issues for users. They are often located in places that are less than ideal, including sensitive habitat.

Currently WDFW law enforcement officers do not have tools to enforce the creation of these user-built trails, some of which have associated signage and infrastructure. The proliferation of user-built trails has become a major area of concern for WDFW land managers. This new rule would make the creation or maintenance of these often environmentally damaging routes and infrastructure illegal with penalties for violation.

**Location of Proposal, including street, if any:** This rule would be applied on a state-wide basis on any lands that WDFW manages.

Lead Agency: Washington Department of Fish and Wildlife (WDFW)
