## DETERMINATION OF NONSIGNIFICANCE (DNS)

# Name of Proposal: DNS 24-030: SOL DUC HATCHERY WEIR PERMANENT REPLACEMENT

### **Description of Proposal:**

WDFW proposes to put out for bid a project to construct a new permanent weir on the Sol Duc River to replace the weir that failed in November 2021 due to high flows. The last weir was precast and modular, this one is proposed to be poured in place and be a double weir to guard against erosion. Elevations of new weir to match original levels of original weir. The new weir will span the river from the existing intake structure to the right bank (approximately 105 feet) and will include a wing wall into the right bank to guard against erosion. A wooden boat ramp will be included for winter drift boat passage. See plans for additional details.
