DETERMINATION OF NONSIGNIFICANCE (DNS)

Name of Proposal: DNS 24-031: FAIRVIEW LAKE GRASS CARP

Description of Proposal: Plant triploid (sterile) grass carp into Fairview Lake to control aquatic vegetation. Future restocking may be necessary due to fish loss.

Fairview Lake is a private lake with no public access. Fairview Lake has a community of homeowners, without an HOA. This community project is to stock the lake with grass carp. A list of Fairview Lake homeowners and residents has been included at the end of the Environmental Checklist indicating their approval.

Location of Proposal, including street, if any: Fairview Lake, entrance located at JM Dickenson Rd SW and Fairview Lake Rd SW, Port Orchard, Kitsap County, Washington: Township 23N, Range 1E, Section 30.

Lead Agency: Washington Department of Fish and Wildlife (WDFW)

WDFW has determined that this proposal will likely not have a significant adverse impact on the environment. Therefore, state law¹ does not require an environmental impact statement (EIS). WDFW made this determination of nonsignificance (DNS) after we reviewed the environmental checklist and other information on file with us.
