**ADDENDUM 24-042 TO DETERMINATION OF NONSIGNIFICANCE (DNS)  
DATED: AUGUST 12, 1996**

**Original Name of Proposal:** PODMAYER – GRASS CARP – PICNIC POINT POND

**Description of Original Proposal 1996:**

Plant triploid grass carp into Picnic Point Pond to control aquatic vegetation.

**Description of Addendum 24-042:**

The Environmental Checklist for the original 1996 DNS did not provide for restocking of grass carp. On behalf of all of the property owners along the pond, the project proponent is requesting to restock grass carp as fish die due to predation or natural die off. Current WDFW Grass Carp Policy (POL 5103) limits restocking to 5-year intervals, with the intent to not overstock the pond or lake.

This Addendum adds restocking to the original proposal and SEPA determination, as well as updates the main project contact and clarifies that there are multiple property owners along the pond.

The original information about the project has been modified as indicated below in underlined font.

**Updated Name of Proposal:** PICNIC POINT POND GRASS CARP

**Description of Updated Proposal:** Plant triploid (sterile) grass carp into Picnic Point Pond to control aquatic vegetation. Future restocking may be necessary due to fish loss.
