First Amendment Comdata Mastercard Corporate Card® Agreement

Except as modified by this First Amendment, all of the terms of the Agreement shall remain in full force and effect. In the event of a conflict between the terms of this First Amendment and the Agreement, the terms of the First Amendment will control. Comdata and Customer both hereby represent and warrant that the person executing this First Amendment on their respective behalf has been duly authorized to execute and deliver this First Amendment and, upon full execution, this First Amendment will be binding upon them in accordance with its terms. This First Amendment may be executed in one or more counterparts, each of which will be deemed to be an original and taken together shall be con as one document. The parties hereto also agree that for purposes of executing this First Amendment, any executed counterpart transmitted by facsimile or PDF scan sent via electronic mail, or any counterpart signed electronically via DocuSign or other similar medium, shall be considered as an original signature and shall have the same binding legal effect as delivery of a manually executed original counterpart.
