## **DETERMINATION OF NONSIGNIFICANCE (DNS)**

Name of Proposal: DNS 24-047: MEEDS GRASS CARP

**Description of Proposal:** Plant triploid (sterile) grass carp into private pond to control aquatic vegetation. Future restocking may be necessary due to fish loss.

**Location of Proposal, including street, if any:** Private pond located at 135 Anchor Road, Castle Rock, Cowlitz County, Washington: Township 10N, Range 02W, Section 27.

**Lead Agency:** Washington Department of Fish and Wildlife (WDFW)

WDFW has determined that this proposal will likely not have a significant adverse impact on the environment. Therefore, state law<sup>1</sup> does not require an environmental impact statement (EIS). WDFW made this determination of nonsignificance (DNS) after we reviewed the environmental checklist and other information on file with us.

We issued this determination according to state rules.<sup>2</sup> Agencies, tribes, and members of the public are invited to comment on this determination. We must receive your comments within 14 days of the date of this document. The comment period will end at 5:00 pm on October 17, 2024.
