

Public Comment Summary

Public Comment Summary

Catch and Effort:

- Target hatchery fish in time and area
- Spread effort by opening more areas (compared to last season) Boat Opportunity:
- Expand or restrict opportunities for fishing from a boat
- Continue to evaluate effects of "no fishing from boats" Season Length:
- Mixed support for April closures or extended seasons

Gear restrictions:

• Support using bait in December to increase hatchery catch, concern for early wild returns

Methods and philosophy:

- Continue to manage using SSMP guidelines (All "H" approach, VSP parameters)
- Continue conservative approach and manage for long term trends
- Increase funding for monitoring and evaluation (harvest rate, encounter rate, mortality estimates, "No fishing from a boat" effects, VSP)

Total Attendees at Townhall #1: 133

Total comments during Townhall #1: ~25 (some were both written and spoken)

Public Portal Comments or Emails: ~30



Willapa Bay public comments

Boat Opportunity:

• Mixed response. Some support boat use, others suggest restrict fishing from a boat on the Naselle and Willapa rivers for conservation and limiting gear conflict

Season Length:

• Do not close tributaries early to spread angler opportunity

Gear restrictions:

- Mixed support for allowing bait in early December
 - Some favor allowing bait during overlap with late hatchery coho, some concern for increased impact on early component of wild steelhead run



Queets, Quinault, Grays Harbor public comments

- Queets Basin, allow fisheries targeting hatchery fish and open Clearwater if impacts allow after hatchery-targeted fisheries.
- Upper Quinault, allow fishing from a boat but implement SGR Dec 1-March 31st.
- Humptulips, provide hatchery-targeted fisheries through mid-January or mid-February.
- Chehalis Basin
 - Provide hatchery-targeted fisheries through February.
 - Allow fishing opportunity in the mainstem Chehalis River.
 - Allow fishing opportunity in March.
 - Allow fishing opportunity in March and use impact saving from "no fishing from a boat" to extend that season.



Hoh and Quillayute public comments

Boat Opportunity:

- Mixed responses including expanding boat opportunity where available or further restrictions
- "No fishing from a boat" study: Mixed response. Balance restricting opportunity with value of study, pair with low forecasted return year.

Season Length:

Mixed response, ranging from open in April to remaining closed and cautious

Gear Restrictions:

• Mixed response to allowing bait in Dec. in hatchery areas and selective gear rules in non-hatchery locations
