To close annually on April 17th, 2025, and reopen September 30th, 2025. WDFW is planning to have subsequent spring closures for the following years or until closure is no longer needed to aid in recovery of State Endangered Sandhill Cranes.

Additionally, concerned citizens have contacted the wildlife area asking for a closure due to trail runners with off-leash dogs coming in very close proximity to the cranes.

WDFW proposes to close portions of the Methow Wildlife Area from April 17th – September 30th. This SEPA checklist is intended to cover the 2025 closure, as well as potential closures in 2026, and other future years of closure implementation. This will include partially closing the Big Valley Unit. This closure will not include any of the other 7 units within the Methow Wildlife Area: Texas Creek, Golden Doe, Methow, Big Buck, Rendezvous, Hunter Mountain, and Early Winters.

The Methow Valley has become a space that offers core nesting habitat for the State Endangered Sandhill Cranes. Since 2020, the Methow Wildlife Area's Big Valley Unit has become the residence for a successful breeding pair of State Endangered Sandhill Cranes. Providing this history and intended purposes of the land within the Methow Wildlife Area the portions of the Big Valley closure will include core wetland, and surrounding areas that provide suitable habitat for nesting Sandhill Cranes. Many of the WDFW lands, within the Methow Wildlife Area were acquired with the intent to protect and maintain core migration corridors and habitat. The Big Valley Unit has offered a place for Sandhill Cranes to successfully nest and raise colts over the past four years with the aid of previous seasonal closures. Closing southern portions of Big Valley has shown to provide a large enough buffer zone to prevent displacement of the nesting pair. Displacement of the breeding pair has been a serious concern over the years as the nesting pair has established Big Valley as their nest location. Additionally, wetlands are one of the most biologically diverse habitats and within the Big Valley Unit. This area is popular with humans and their dogs due to the community trail, large array of wildlife that inhabit the wetlands and more specifically the rareness of spotting a Sandhill Crane. Thus, this closure is intended to aid and protect a core habitat, migratory corridor and nesting area for the State Endangered Sandhill Crane. These closures will be centered around areas that provide core nesting habitat and are known Sandhill Crane activity areas.

Areas to be closed (Approx. 240 Acres) within the Big Valley unit will be thoroughly delineated with closure signs, physical barriers, and maps detailing the closure boundaries. No public access will be permitted within the closure

boundaries. The closure will begin at 12:01 a.m. on April 17th, 2025, and end at 11:59 p.m. in September 2025. As noted above, there may be similar spring closures in subsequent years.

Yes, the proposed closure will displace all forms of recreation within the closure boundaries, which only accounts for approximately 240 acres of WDFW managed land in the Methow watershed. Habitat adjacent and surrounding the agricultural field consists of deciduous shrubs and wetland habitat. A small portion of a public trail, which is managed by Methow Trails will also be closed, but Methow Trails is fully supportive and understanding of the need to close the area to provide a sufficient buffer to the nesting pair of Sandhill Cranes.

Six wildlife area units are not impacted by this closure. The one unit included in the closure is only partially closed to ensure each unit can provide sufficient recreational opportunities. WDFW is providing trail recreation at the Big Valley and Lloyd Ranch.
