Reflections, establishing knowledge base

"Identify all avian species that contribute to predation of juvenile salmon at a population level"

- Is it possible to answer this question in whole?
- We can identify avian species that predate on salmonids; is it possible to identify at a population level?
- What other info do we need to answer "at a population level"? Can we?

Scope of report

- **OBJECTIVE:** Identify working definition of "impact"
- Part of the report should be an opportunity to gather potential different definitions of "impact," so the legislature understand the scope of what they asked for?
 - Avian predation in a specific place at a specific time IS IT MEASURABLE?
 - *If it is measurable IS IT ADDITIVE?*
 - If so then perhaps it is predation that is "impactful" at that spatial and temporal scale

Scope of report

"Identify remedies to predation"

- **OBJECTIVE:** Establish a shared vision of how the report will discuss remedies
- The legislature directed the group to identify remedies what more information does this group need to be able to accomplish this?
- There are different scales you could consider when "identifying remedies." How do you think the group should approach answering that question? At what scale do you think you should be answering this question?
