Other Funded Provisos:

- Avian Predation/Salmon: \$222K Funding is provided for Substitute House Bill 2293, which creates an avian salmon predation work group.
- **Bear Wise: \$224K** Funding is provided to conduct bear hazard assessments in communities with historically high levels of human-bear conflict.
- Invasive Mussels: \$3,620K Funding is provided for monitoring and response efforts for invasive quagga mussels, including coordination with other entities, inspections, decontamination, equipment, training, monitoring, and outreach. Matching federal funds are anticipated from the U.S. Army Corps of Engineers.
- Orca Monitoring and Research: \$100K Funding is provided for a grant to an orca research organization in Friday Harbor for monitoring and researching Southern Resident killer whales.
- Ruckelshaus FY Shift: In the 2023-25 operating budget, \$300K was provided to the Ruckelshaus Center for a review of WDFW in FY 2024. This item shifts \$95K of that funding from FY 2024 to FY 2025 report due date moved from June to December.
- **Skagit Elk Management: \$100K** Funding is provided for elk management in the Skagit Valley in cooperation with affected tribes and landowners, including fencing, replacement seed and fertilizer, and elk deterrent equipment.



Supplemental Capital Items

Federal authority was provided in both versions of the Capital budget for these projects:

- Mitchell Act BiOp Implementation \$536k
- Ringold Hatchery Replace Ponds \$10.8M
- Washougal Intake Replacement \$14.2M



Supplemental Capital Items – cont.

Two capital bonds requests were funded:

- Sekiu Boat Ramp Acquisition, \$2.7M.
- Minor Works Preservation Domestic Water Systems and Piping, \$275k.

These increases show up in the capital budget of the Recreation and Conservation Office:

- Brian Abbott Fish Barrier Removal Board \$22M
- Estuary and Salmon Restoration Program \$11M
- Washington Coastal Restoration and Resiliency Initiative \$8M



Specific issues from last session to pursue jointly with Tribes

Ongoing support for SRKW prey production – specifics like production in partnership with the Squaxin Island Tribe.

Coordinating ungulate survey flights and wolf collaring with the Confederated Tribes of the Colville Reservation.
