


WA State Landings and Ex-vessel Value



 - Next technical discussion is planned for Nov 21.




Technical Meetings w/ Quinault

- 2. Be agreed upon prior to, and included within, the co-management agreement



Approach





Management Tools

- 1. Tribal head start
 - Improve the sliding scale
- 2. Pot limits
 - Start of season/in-season
- 3. Area restrictions
 - Start of season/in-season




Sliding Scale Methodology

The number of tribal head start days is determined by Quinault's total catch (in lbs) within the <u>first 31 days</u> of fishing:

Season Type	Total in 31	Head Start Days
low	< 1,250,000	45
med	1,250,000 - 1,500,000	46
high	> 1,500,000	47




Sliding Scale Methodology



Total QIN Catch in first 31 days (lbs)




Low vs. High Abundance Years

low-med	1,000,000 - 1,250,000	45
med	1,250,000 - 1,500,000	46
med-high	1,500,000 - 1,750,000	47
high	> 1,750,000	49

Ove the past 10 seasons, head start days given have not been linked to crab abundance:

Abundance (old scale)	Head Start Days Given
Low	43 – 48
Medium	44 – 49
High	46 – 49



Electronic Monitoring Update

- 1. Commission meets on Friday
- 2. Currently soliciting applications for a free EM system (10/25 deadline for first priority)
- 3. Technicians will be available to assist with install
- Rule goes into effect January 1, 2024



Conservation Plan Update

- Conservation Plan (CP) Update: drafting slowed, new WDFW CP Coordinator hired!
- Work on risk reduction measures ongoing
- 2023 Rule Package focused on CP Monitoring Program
 - Gear Marking and Electronic Monitoring
 - Proposed rules build on measures already in place
- 2024 rule to expand line marking requirements, coordination with West Coast states and NMFS



Take Reduction Team

Doc #: 2023-21333 <u>Federal Register :: Scoping for a Marine Mammal</u> <u>Take Reduction Team to Address Incidental Mortality and Serious Injury</u> <u>of Humpback Whale Stocks in the Pacific</u>

- Section 118(f)(1) of the MMPA requires NMFS to develop and implement TRPs designed to assist in the recovery or prevent the depletion of each strategic stock that interacts with Category I and II fisheries (16 U.S.C. 1387(f)(1))
- WA crab and sablefish pot are Cat II fisheries.
- NMFS is seeking public input on the scope of the TRT
- Additional information relevant to establishing this TRT includes information about the factors associated with risks of humpback whale or other large whale entanglements in U.S. commercial fisheries in the Pacific Ocean.
- NMFS is seeking to identify interested stakeholders who may wish to serve as TRT members.
