Fish Passage Strategy – Optimization Model Development (Ongoing)	WDFW staff are moving forward with developing the optimization model in-house with support from Cramer Fish Sciences. WDFW staff will provide updates to the Board regularly.
Funding Status Updates ( <i>Ongoing</i> )	WDFW and RCO will keep the Board updated on the status of returned funds. A decision on whether to: 1) retain funds for cost increases, or 2) advance funds to alternates down the ranked project list is anticipated this fall/winter.

Welcome/Introductions/Agenda Review:

Triangle Associates (Triangle) facilitator, Joy Juelson, called the meeting to order at 9:00 a.m. Chair Thomas Jameson, Washington Department of Fish and Wildlife (WDFW), welcomed attendees to the virtual meeting.

Joy, Triangle, facilitated introductions with Board members and staff. A quorum was present.

## **Old Business:**

Kate Galambos, Triangle, reviewed the summary notes from the December 14, 2024, meeting and highlighted decisions and action items.

## Decision: Approval of December 14 Meeting Summary

Chair Jameson made a motion to approve the December 14th meeting summary with edits made on the screen to update the cost increase request for Fletcher Bay to \$457,146. John Box seconded the motion. With no objections, the December meeting summary was approved.

## Upcoming Decisions on the Manual 22 Updates, Kaylee Kautz, WDFW

Kaylee explained the upcoming anticipated decisions for the Board to consider prior to the updates to Manual 22 in August 2025. The Policy Subcommittee will meet over the upcoming months to discuss the following topics, starting with the project list funding line, and will bring recommendations to the Board.

- Project list funding line
- Project eligibility requirements
- Match requirements

## Project List Funding Line

Kaylee noted that staff will consider project eligibility requirements in parallel with considering the project list funding line.

## **Match Modernization**

In prior Board conversations regarding match modernization, Board members identified that rural cities and counties are disadvantaged because they do not have the tax revenue to provide match locally. RCO staff have also been gathering data from the 2017-2019 grant round (prior to the match requirement) to inform an updated to Manual 22. Staff will present this data during the February Cost Increase Subcommittee meeting.

The Salmon Recovery Funding Board (SRF Board) has implemented match modernization already. John Foltz, RCO, noted key differences between the SRF Board and FBRB:

- SRF Board has federal funding available through NOAA's Pacific Coastal Salmon Recovery Funding (PCSRF)
- The Board did have access to federal funding through PROTECT (Promotion Resilient Operations for Transformative, Efficient, and Cost-saving Transportation Program) to fund the 25-27 list. It is unlikely that the Board will have access to federal funds in the future.

- Due to available funding, the Board was able to fund more projects on the 25-27 list. However, in the past, a funding line would have been unnecessary because there was not enough available funding to fund projects lower on the list.
- A project funding line could disadvantage city projects; Chair Jameson noted that Carl Schroader should be part of these conversations to represent the Association of Cities.
- Steve Manlow noted that his region, the Lower Columbia, uses a project funding line and recommended that the Board reach out to other Lead Entities to understand how they use funding lines.

## The purpose of Kaylee's update was to prepare the Board; there was no required decision.

*Path Forward:* The Policy Subcommittee will meet monthly to discuss the topics above and bring recommendations to the Board.

## **Funding Status Updates**

John provided an update to the Board on the status of available funds, including the Climate Commitment Act (CCA) funding. Previously, staff understood that the CCA funding could not be applied to projects that have already received capital funding, which would limit the funding to projects 71-102 on the 23-25 project list. After clarification, RCO now understands that CCA funding can be used for funding cost increase requests that have already received capital funds. The Board now has more flexibility with how use funds and can apply CCA funds to fund cost increase requests for projects that are higher on the list (not just those that are below project 70).

Projects 32-102 on the 23-25 list are eligible for CCA funds. John has not reached out to project sponsors for 101 and 102 due to the size of the requests. John will reach out to these sponsors once he has finished working with sponsors higher on the list.

*Path Forward:* John will continue to work with project sponsors on the 23-25 to award funding based on the funds made available by the CCA

## Cost Increase Requests, John Foltz, RCO

John Foltz provided an overview of two cost increase requests along with the recommendations from the Cost Increase Subcommittee. Additionally, John walked through an additional request for a project RCO offered funding for in December, which the sponsor initially declined.

The Board has sufficient funding available to support all three requests.

## 1. 21-1393 Mill Creek Barrier Improvements NE 259th St.-61st Ave.

- a. Sponsor: Clark County
- b. Requested Cost Increase: \$98,260
- c. Cost increase largely due to inflation

# Decision: Approve 21-1393 Mill Creek Barrier Improvements NE 259th St.-61st Ave. Cost Increase

Steve Manlow made a motion to approve \$98,260 for the Mill Creek improvements cost increase request. Chair Jameson seconded the motion. The cost increase was approved.

## 2. 21-1504 Panther Creek Barrier Removal – Talbot Road

- a. Sponsor: City of Renton
- b. Requested Cost Increase: \$950,000

c. Cost increase request due to better understanding of the project site based on completion and review of design alternatives.

## Decision: Do Not Approve 21-1504 Panther Creek Barrier Removal – Talbot Road Cost Increase

Chair Jameson a motion to waive the requirement of final design for the project sponsor to allow to rescope the project using the existing funding and not approve the cost increase request. The Board will revisit the request at June 2025 cost increase subcommittee meeting. Erik N. seconded the motion to approve.

## Additional Request: 21-1433 Mill Creek Passage Design Colville to 3rd

- Sponsor: Tri-State Steelheaders (Salmon Enhancement Group)
- Requested Funding: \$196,000
- The sponsor was initially offered CCA funding and declined. The sponsor returned and asked for funding after further consideration.

## Decision: Approval of funding for 21-1433 Mill Creek Passage Design Colville to 3rd

Chair Jameson made a motion to approve funding for project 21-1433 Mill Creek Passage Design Colville to 3rd for \$196,000. Erik seconded the motion. The funding was approved.

## Fish Passage Strategy Update, Jane Atha, WDFW

Jane Atha gave a brief update on the status of the Fish Passage Strategy:

- The Fish Passage Strategy project team met with WDFW GIS staff on Friday, January 17 to start developing the optimization model.
- WDFW staff decided to pilot the tool on one watershed the Stillaguamish which was chosen because there are two hydrography layers available for the watershed.
- The Strategy has an updated description on how it will be implemented, which reflects the presentation the Board heard from the Fish Passage Prioritization Strategy project team in spring 2024.

## Upcoming Opportunities for Engagement, Chair Jameson, WDFW

- Washington Legislative session began on Monday, January 13<sup>th</sup>. Members identified HB 1288 as a bill to track. The proposed bill aims to amend the priorities of the CCA and does not name the FBRB. See bill information here: <u>HB 1288 2025-26</u>
- Puget Sound Partnership (PSP) hosts a weekly legislative update call on Fridays. See information here: <u>2025 Legislative Updates</u>
- Yakima Nation is working on a project with NOAA funding with 3 dam diversion projects as pass through projects.
- The Washington State Recreation and Conservation Office, Salmon Recovery Conference has been cancelled due to the state travel freeze.

Next Meeting: The next FBRB meeting is scheduled for February 18th, virtually.
