

Over the next decade, Puget Sound habitat recovery will be guided and influenced by the decisions at budget, policy, rulemaking, and planning milestones occurring across many geographic, government, and organizational scales. These are opportunities and potential inflection points that should inform when and how we focus on actions for implementation the Habitat Implementation Strategies and Puget Sound Action Agenda. To inform the recommendations process, HSIL staff have drafted an initial list of some of these milestones that will occur between 2025 and 2035. This is a preliminary list. HSIL requests HSIAT members identify additional milestones to contribute during the June 18, 2025 meeting. Milestones should reflect the diverse suite of decision-makers and decision points that intersect within Puget Sound recovery.
