2024 / 2025 – Management Updates

Scrap / Weighback

- **Catch rejected by buyers is required to be recorded on a fish ticket.**
 - Recorded as Scrap / Weighback
 - Once an offload starts everything ***must*** be recorded on fish ticket.
 - Includes catch that is alive and may be released successfully or brought and sold to other buyers.
 - Buyers are legally obligated to record scrap/ weighback.

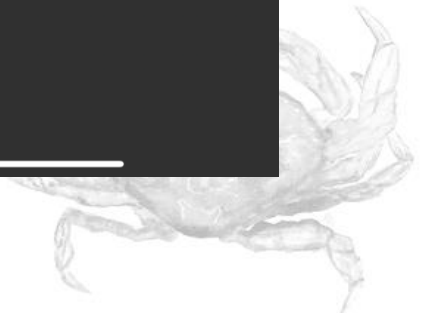

Fish Ticket Submission

- **Fish tickets are expected to be filled out and submitted as soon as the transaction is complete or the catch transfers hands.**
 - Those acting using a limited fish seller endorsement are expected to meet the same standards as a wholesale dealer.
- **The original receiver acting in the capacity of a buyer/dealer must do the following:**
 - Completely fill out a fish ticket, including the weight, at the conclusion of an offload and prior to the catch being transported away from the offload site or the harvester leaving the offload site.
 - Those using a mobile device are required to fill out a fish ticket at the delivery location and submit it to the department upon completion of the offload.
- **Violation of these regulations may be punishable as a felony.**



Fish Ticket Submission

- **Fish tickets should reflect landings on a single delivery.**
 - Keeping fish tickets open for harvesters to return to fishing and deliver again may violate fish ticket submission rules.
 - Submit fish tickets following each delivery.



WaTix Updates

- **Editing of submitted fish tickets is not locked 72 hours after submission.**
 - Contact fishery managers or WaTix Support if you need to edit a ticket after 72 hours.
- **The mobile apps (iOS, Android) have had user interface improvements.**
 - Fixed buttons to edit or void a fish ticket or modify catch lines (no swiping).
 - Lines are more visually discriminated.
- **The web app (<https://apps.wdfw-fish.us/watix>) has some user interface and quality-of-life improvements.**
 - Fish ticket printouts can now be downloaded in batches.
 - Columns can be reorganized and filtered

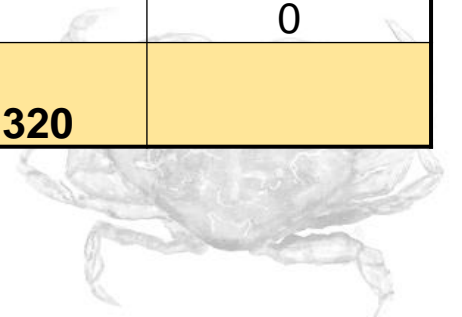

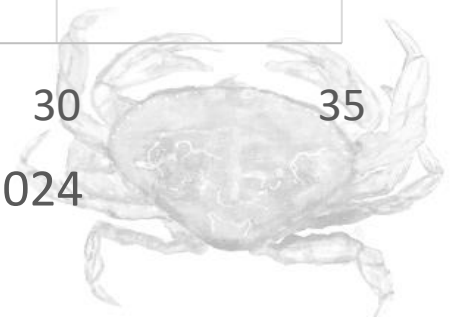
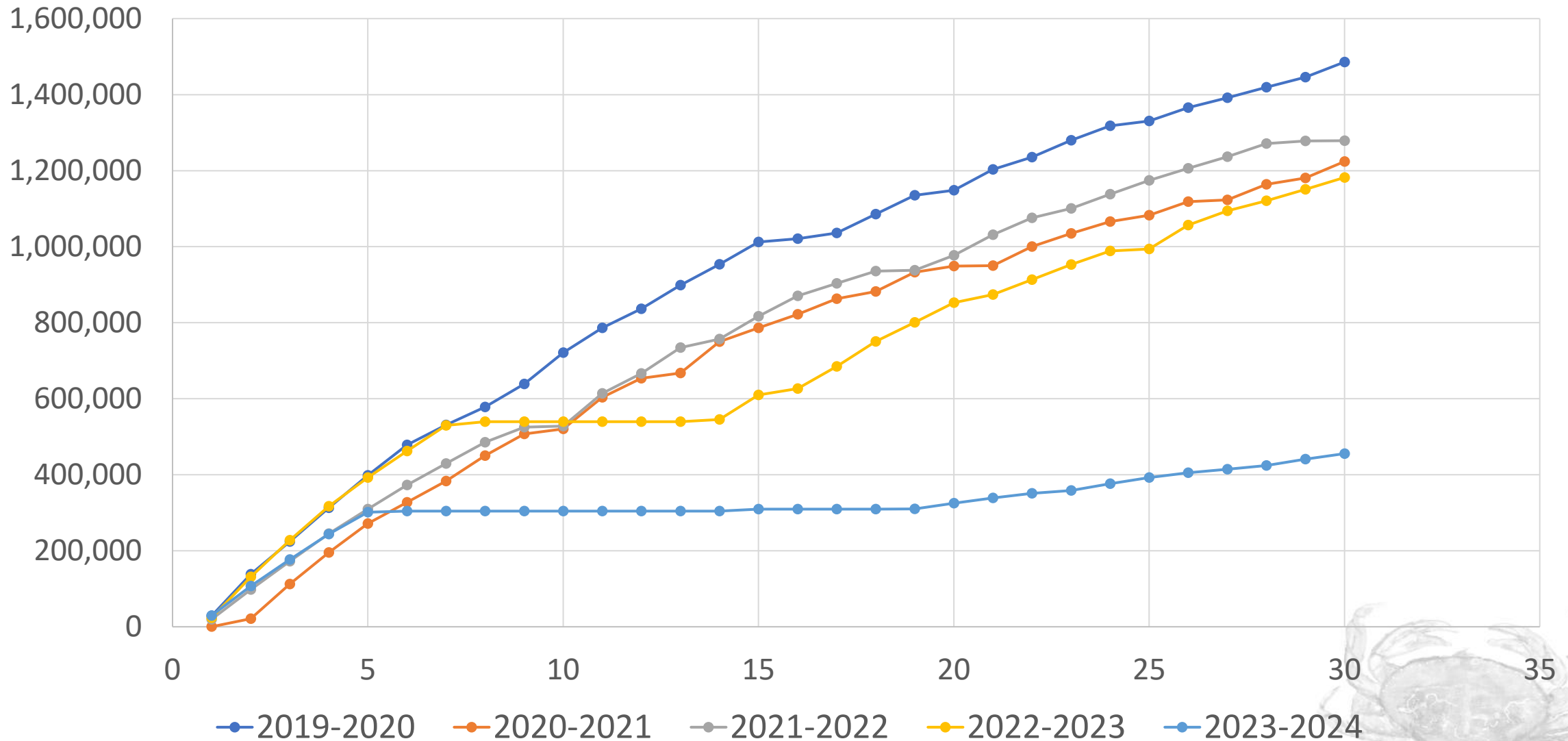

Questions on the November Retainer:

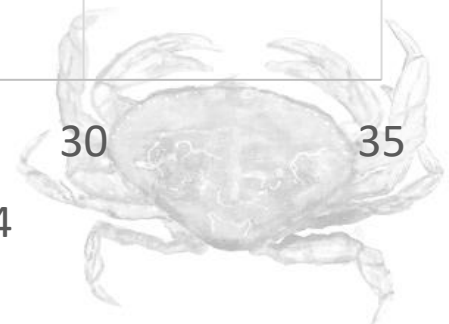
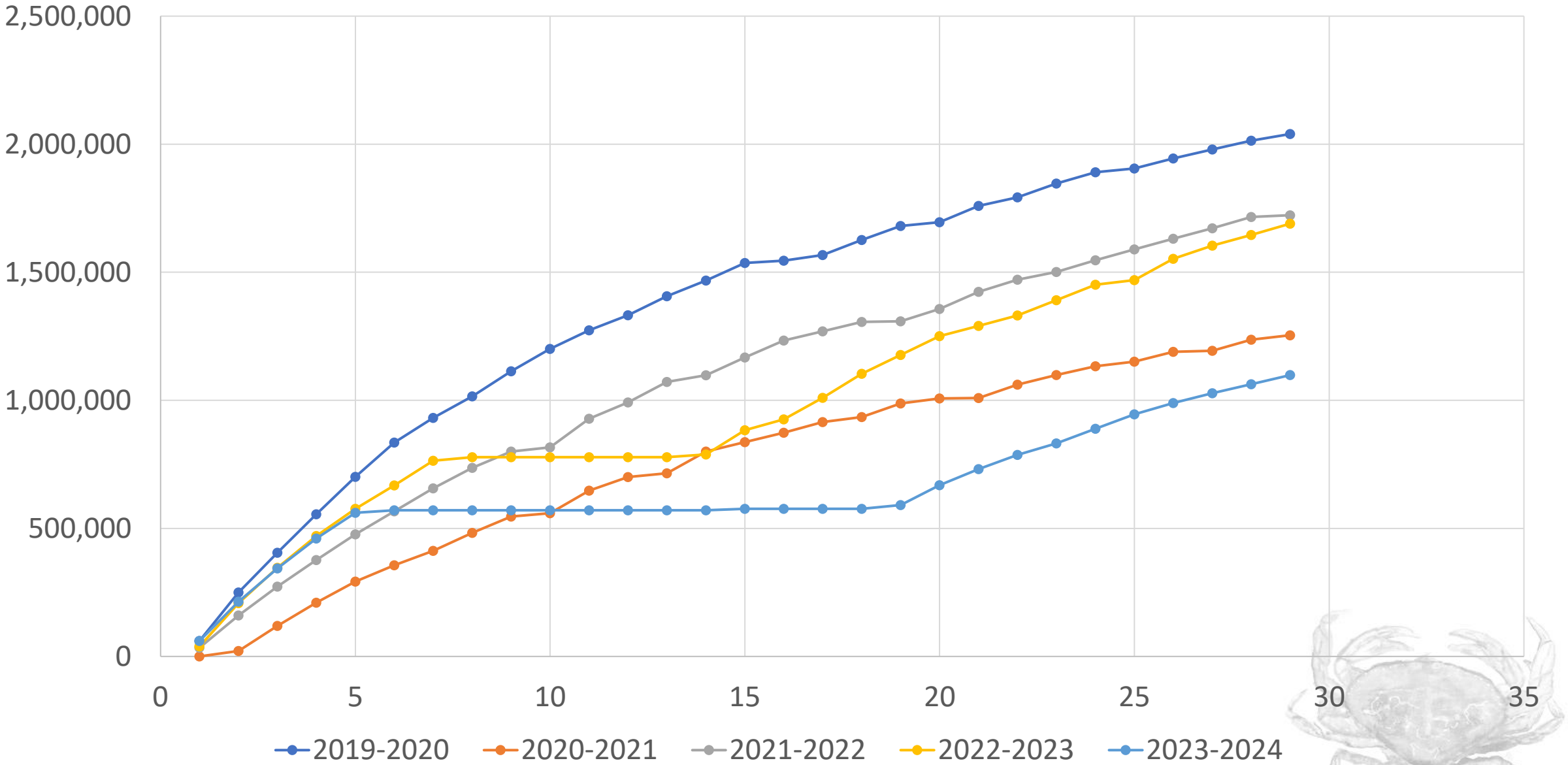
- Is the 1-million-pound threshold for harvest from Region 1 only or all regions combined?
- Will all regions be closed or just Region 1 when the 1-million-pound threshold is hit?
- Is there a price per pound threshold that should be implemented to stop the retainer closure?
- Are there any concerns /risks with implementing a November Retainer / pause?

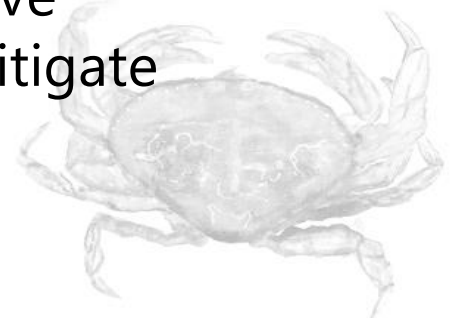

November Retainer: *Once total Region 1 harvest is greater than or equal to 1,000,000 lbs then close until November 10, 2024. If Region 1 harvest remains less than 1,000,000 lbs then remain open.*

Set-Aside: 150,000 lbs

Questions on the Set-Aside:

- What date should the set-aside be held until?
- Are there criteria other than date that should be considered to initiate earlier fishing? (i.e. Market price, time since the start of the coastal fishery, shell condition, etc.)
- Are there any concerns regarding a set-aside? If so, do you have suggestions that would mitigate them?



2024 / 2025 State Proposal

Season Proposal:

October 1 opening in all areas.

- **Region 1** with **35 pots**
- **Region 2E** with **30 pots**
- **Region 2W** with **30 pots**
- **Subregion 3-1** with **50 pots**
- **Subregion 3-2** with **40 pots**
- **Subregion 3-3** with **50 pots**
- **Subregion 3-4** with **50 pots**

November Retainer: *Once total Region 1 harvest is greater than or equal to 1,000,000 lbs then close until November 10, 2024. If Region 1 harvest remains less than 1,000,000 lbs then remain open.*

Set-Aside: 150,000 lbs (Feb.1 start-date)

Modifications:

Increased pot limits in 2W and 2E to 30 matching the minimum pot level that was communicated last year.

Increased pot limit in 3-2 to reflect other industry input.

Start targeting the set-aside earlier March.
