## DISCUSSION Budget Update

Steve discussed the current budget. He noted that the actual budget has not been finalized as of yet. CONCLUSIONS

We have exceeded the revenue planned in July and August. We spent \$496,000 less in last biennium than we had planned, probably because folks held off with expenditures to get us through. Our expenses will see an increase in food costs, a 3% increase in salaries now that we no longer have the furlough, and some salary increases due to step increases for classified employees who have been in their position for over four years. The concern is to get approval to spend more money through the spending authority and to have a pool available for creative/innovative projects. We need to maintain \$400,000 as a buffer during lean winter months.
