




USFS Projects

- Little Tucannon Bridge
 - Longer span with more room underneath
 - Road near Watson Lake Parking Area
 - Large wood structures for road protection





Floodplain Management Plan

Submitted for Capitol Projects for 2023-25



Governor's budget = \$1M, Senate budget = \$0, House budget = \$0



Floodplain Management Plan

- PA 5-15 Assessment
 - Co-Managers
 - WDFW, CTUIR, and Nez Perce Tribe
 - From Camp Wooten to Russell Unit
 - Assessment and conceptual design
 - Look at options for rehabbing or improving all lakes
 - Look at campgrounds, roads, powerline burial, and all infrastructure located in floodplain
 - Timeline:
 - Project Start Date September 1, 2023
 - Project End Date December 31, 2024

Noxious Weed Control Grants

- 2023 Grants
 - Rocky Mtn Elk Foundation grant
 - \$15,000 to spray 360 acres
 - Mule Deer Foundation grant
 - \$8,000 to spray 225 acres
- 2024 Grants
 - \$15,000 requested from RMEF
 - 300 acres



Large Wood Projects

- Rainbow Lake Inlet to Hatchery Bridge
 - Phase 1 completed 2022, Phase 2 completed 2023
 - Engineered log jams
 - BPA funded for habitat restoration for spring Chinook and steelhead
- Cummings Creek- Phase 1 (Nez Perce Tribe)
 - Treat 1 mile upstream from mouth of Cummings Creek
 - Post Assist Log structures (PALS)
 - Salmon Recovery Board funded
 - Construction planned Summer 2023

Educational Hides & Skulls

- 2022 Redband Cellars (Dayton, WA)
 - \$1,000 to Touchet Valley Taxidermy & Tanning
 - Paid for porcupine hide, fox hide, badger hide, and bear hide & skull
- Warren Community Action Fund
 - Blue Mountain Community Foundation
 - Asked for \$1,500 for more hides & skulls
 - · Did not receive any funding
- Hides and skulls used for educational talks at Camp Wooten ELC, The Club, school groups, 4-H groups, civic groups, etc
 - Also used in Fair Booth

Budget Reconciliation Funds

Purchased:

- New well (2021)
- New siding on Wooten Headquarters (2022)
- Garage door opener (2023)
- 2006 International 7400 SBA Dump Truck (2023)
- 2023 MAXXD LDX Equipment Trailer (2023)
- Security Cameras (2023)

Requests:

- Mini-excavator with bucket and brush-cutter head
- Pole building construction



Bighorn Sheep Update

- Currently have 13 sheep in the herd
 - 2 lambs surviving from last year (out of 4 documented)
- Herd still on private land north of the wildlife area
- WDFW has no plans to supplement the herd with new animals
 - Will continue to try to ground dart and collar the sheep as opportunities present themselves





Wolf Update

- Columbia Pack
 - 1 working collar, 1 non-working
- **Tucannon Pack**
 - 0 working collars
- Touchet Pack
 - 1 working collar but dispersed
- 139 Group
 - 1 working collar but wolf died
- **Butte Creek Pack**
 - 0 working collars
- **Grouse Flats Pack**
 - 2 working collars
- Pack counts done January-March due to packs being more cohesive and numbers being at their lowest of the year due to sub-adults dispersing and pups not surviving winter



Elk Calf Mortality Study

- 2021 125 calves collared
 - 13.6% survival through January
 - 78% of mortalities were predation
 - 57.6% cougar
- 2022 102 calves collared
 - 47.5% survival through January
 - 77% of mortalities were predation
- 2023 115 calves collared
 - Survival to date higher than past 2 years
 - Final results not available yet



Elk Calf Mortality Study

- Survival tracked for 1 year
- 11 calves marked in 2022 harvested as spikes in 2023
 - 9 no longer had collars but still had ear tags
 - 2 had working collars
- Shed-collar rate same in 2023 as in 2022
 - Sample sizes were greater than 100 animals in anticipation of collars falling off or not working










Walla Walla Property Update

- Continue weed control and litter cleanup
- McDonald Road Unit
 - Renewed ag lease

Maloney Mountain Property

- 145.82 acres
- Landowner contacted WDFW regarding purchase
- RCO Grant
 - Was funded through RCO but funding was pulled at the last minute
