



# Spawn in the upper Chehalis, Skookumchuck, and Newaukum rivers.



# Spawn in major tributaries and the mainstem Chehalis.




# Spawn in all major tributaries and the mainstem Humptulips.

### **Chehalis** Coho


# Spawn in tributaries throughout the Chehalis watershed.





### **Grays Harbor Fisheries**

#### **Draft Management Plan**


- 2005-2009 Developed with stakeholder input
- Provides WDFW managed fishery guidance
- Recreational Fishery Greater share of catch at low abundance
- Commercial Fishery Increased share of catch at high abundance
- Tier System describes fisheries at different abundance levels

### Grays Harbor Fisheries Catches (average 2000-2012)








