Amend WAC 232-28-342:

- Small game animals
- Upland game birds
- Forest grouse
- Wild turkey









Minor Changes:

- Status quo calendar date adjustments
- Add adult mentor requirement—youth turkey season
- Remove turkey weapon restrictions
 - Move to WAC 232-12-047
- Remove band-tailed pigeon reporting requirements
 - Move to WAC 232-28-299
- Reformat fall turkey general seasons

Forest Grouse:

- Bag Limit increase in 2009 has been a concern among some hunters and biologists
- Spruce grouse a particular concern
- Habitat and weather are primary limiting factors

Proposed split bag limit:

- Four total per day
- Limit of 3 blue, 3 ruffed, 3 spruce

Proposed split bag limit:

- Alternatives survey:
 - Status quo: 176
 - Total 4 (3 spruce): 147
 - Total 4 (3 each species): 96 (recommended option)
 - (many suggested to lower to three)
- Comments:
 - Concerned with species ID
 - Just lower total to 3
 - Keep at 4



Red Fox:

Remove closure in GMUs 407 and 410

- Introduced population
- No Cascade red fox in area
- Provides additional opportunity



Pheasant:

End season on Martin Luther King holiday:

- Retain start at Saturday following MF deer opener
- Additional opportunity
- Should not affect population



Mourning Dove:

Increase bag limit and season length:

- Sept 1 Oct 30 season
- Increase bag limit from 10 to 15
- Follows national mourning dove harvest strategy
- Additional opportunity



Amend WAC 232-28-242:

Allow expanded opportunity Sept, Oct, Nov

- Raccoon, bobcat, coyote
- Currently precludes hound/night hunting for 3 months
- Longstanding request of raccoon hunters
- Some concerns regarding conflicts or abuse
- Maintain restriction during MF deer/elk general seasons
- Remove dual reference from WAC 232-12-288
