Background summary:

In 2008, the Washington Department of Fish and Wildlife (WDFW) completed a Statewide Steelhead Management Plan (SSMP) that outlined policies, strategies, and actions (WDFW 2008) to address steelhead conservation and recovery. The SSMP highlighted WDFW activities that would contribute directly to recovery of steelhead populations and reduce threats to wild steelhead viability. One of the requirements of the SSMP was to provide a report on atrisk stocks of wild steelhead to the Fish and Wildlife Commission and Director.

The purpose of the briefing is to provide an overview of the Steelhead At Risk Report including which populations are most at risk, summary of statewide and regional threats, and key management strategies and actions to address those threats.

Steelhead trout, the anadromous form of *Oncorhynchus mykiss*, are the state fish and are of tremendous cultural and economic value in Washington State. Unfortunately, steelhead have declined significantly in abundance throughout their range and are currently at a fraction of their historic abundance and distribution across the Pacific Northwest. In the late 1990's many steelhead populations were federally listed under the Endangered Species Act (ESA), with the most recent federal listing occurring in Puget Sound in 2007. NOAA has identified several factors that contributed to steelhead decline including fishery management, hatchery practices, habitat degradation, dams and culvert barriers, disease and pathogens, inadequacy of regulatory mechanisms, and natural and other manmade threats. Currently, five of the seven steelhead Distinct Population Segments (DPS) in Washington State are listed as federally threatened under the ESA.
