## Friday, August 21, 2015

Vice Chair Carpenter called the meeting to order at 8:30 a.m.

### A. Petition to Change Rules - Decision

The Commission formally considered a petition filed by the Humane Society of the United States, Conservation Northwest, Center for Biological Diversity, Mountain Lion Foundation, Wolf Haven International, The Cougar Fund, The Lands Council, Predator Defense, Kettle Range Conservation Group, and Gary Koehler, Ph.D. (hereafter, referred to as petitioners). The petition requested that the Commission effectively vacate its decision to increase the cougar harvest guidelines in 14 hunt areas of the State from 17-21%, and change the harvest guidelines back to the 12-16% recommended by the Department and reflected in the proposed rule. The petitioners made the following arguments in support of their petition: there is a lack of public involvement and opportunity for input on the proposed amendment; the 17-21% harvest guidelines deviates from the best available science; the proposed amendment is substantially different from the proposed rule; and increased harvest may disrupt cougar social structure which may result in increased cougar-human and cougar-livestock conflicts, and, as a result, will decrease social tolerance for cougars.

Donny Martorello, Wolf Policy Lead and Nate Pamplin, Assistant Director, Wildlife Program provided the Commission with a detailed briefing and recommendation from the Department.

**Commissioner Thorburn made a motion to deny the June 30, 2015 petition that the Commission initiate rulemaking to amend WAC 232-28-297 to reduce cougar harvest guidelines in 14 hunt areas of the State from 17-21% to 12-16% and further directed the Department to provide a recommendation for the 2016 and 2017 cougar hunting seasons at the March-April 2016**

**Commission meetings. Commissioner Wecker seconded the motion. The motion passed with a vote of 7-1.**

**B. 2016 Operating Budget Request - Decision**

Owen Rowe, Budget Manager, requested approval of the proposed 2016 Operating Budget.

**Commissioner Thorburn moved, seconded by Commissioner Wecker to approve the proposed 2016 Operating Budget request as proposed, All were in favor and the motion passed.**

**C. 2016 Legislative Proposals - Decision**

Ann Larson, Legislative Liaison, requested approval of the proposed 2016 Legislative proposals.

**Commissioner Smith moved, seconded by Commissioner Wecker to approve the proposed 2016 Legislative proposals as proposed, All were in favor and the motion passed.**

**D. Meeting Minute Approval – Decision**

The Commission approved the meeting minutes of the August 7-8, 2015 meeting.

**Commissioner Thorburn moved, seconded by Commissioner Wecker to approve the August 7-8, 2015 meeting minutes as presented, all were in favor and the motion passed.**
