The Department is recommending the following action:

Item 1 – Proposed Acquisition of 2,061 acres +/- in Asotin County

Item 2 – Proposed Acquisition of 572 acres +/- in Cowlitz County

Policy issue(s) you are bringing to the Commission for consideration:

Protecting critical fish and wildlife habitat, and providing public recreational opportunities.

Public involvement process used and what you learned:

Item 1 – This acquisition is to purchase the fifth phase of the Odom/4-O Land & Livestock LLC property in Asotin County and was approved through the Department's Lands 20/20 Process and funded through the legislatively approved WWRP Critical Habitat grant. This phase contains approximately 2,061 +/- acres and completes over 90% of the land to be purchased from this landowner.

Item 2 – This acquisition is to purchase 572 acres +/-as the first phase of the Merrill Lake Properties LLC property in Cowlitz County and was approved through the department's Lands 20/20 process and funded through the legislatively approved WWRP Riparian Protection grant. This phase will contain a substantial portion of Merrill Lake shoreline and frontage on the Kalama River.

Action requested:

Approval of the proposed land transactions as presented.

Move to approve the proposed land transactions as presented.

Justification for Commission action:

This action will provide protection for critical fish and wildlife habitat and provide public recreational opportunity.

WDFW will provide a press release informing the public of this action and proceed forward to closing the transaction.


