Cross Region Proposals Clarify fishing "fly" definition

- Clarify definition
- Add language about materials that may be used to construct flies

Cross Region Proposals Clarify fishing "fly" definition (57)

- Pro (65%)
 - Reasonable given prolific use of foam and rubber
 - More consistent with how flies are currently tied
- Con (7%)
 - Waste of time and money
- General Comments (28%)
 - More extensive updating needed
 - Add beads
 - Add "and similar materials" –can't cover everything
 - Do not allow the use of lead
 - Clarify what is <u>not</u> a fly instead

Remove internal combustion motors prohibition on small streams

- Remove ICM restrictions where they are not practicable
- Simplify and reduce language in pamphlet

Remove internal combustion motors prohibition on small streams (28)

- Pro (36%)
 - Support making regulations less convoluted
 - Reduces text in pamphlet
- Con (46%)
 - Use boat length and horse power restrictions instead
- General (18%)
 - Define what is meant by small streams or small flows

Allow harvest of Grass Carp

- Initial use was to control aquatic vegetation
 - Overstocking and fish longevity resulted in overgrazing
 - Use harvest as a tool to reduce abundance and impacts

Allow harvest of Grass Carp (31)

Pro (81%)

- Add Duck Lake (Grays Harbor County);
- Consider mandatory retention;
- Lone Lake has been overgrazed and some carp thinning should help
- Con (13%, all against adding Duck Lake)
 - Don't add Duck Lake because of recent increase in vegetation
- General (6%)
 - Only adopt if the rest of the fish population is not impacted

Allow retention of stray hatchery Steelhead

- Allows anglers to keep stray hatchery fish
- Reduces potential for unwanted genetic and competitive interactions with wild steelhead

Allow retention of stray hatchery Steelhead (55)

- Pro (85%):
 - Win-win for recreational anglers and conservation
 - Responsible thing to do
 - Don't consider as part of the daily limit
 - Don't require to be recorded on the catch record card
- Con (5%)
 - Will lead to abuse and catching of non-stray steelhead
 - Will negatively impact diversity
- General (9%)
 - If don't plant them, won't have a problem

Public is requesting more year-round fishing opportunity

Provide additional year-round opportunity (83)

- Pro (37%):
 - Many lakes have algae blooms in summer
 - Add Lake Whatcom
 - Summit Lake
 - Increased opportunity for Kokanee in early spring
 - More legal fishers will help decrease theft

Con (60%): All Summit Lake


- Loss of Fisherman's Breakfast revenue
- Need of an Environmental Impact Statement
- Water quality concerns --drinking water from the lake
- Increased theft to properties
- Clean up and boat launch maintenance

General (3%)

 Request for more areas on these water for elderly and disabled to fish successfully Washington Department of Fish and Wildlife;
 Information subject to changes and amendments over time

Increase Trout fishing opportunity in streams

- Add additional angling days to fisheries
- Flett Creek and Leach Creek





Increase Trout fishing opportunity in streams (28)

- Pro (29%):
 - Native fish have been extirpated for a long time, no negative impacts
 - Support increasing trout fishing opportunities
- Con (39%):
 - Flett Creek cutthroat have greater value to recreational fishers in the Puget Sound salt waters
 - Small streams, cannot take much pressure
 - Need more sanctuaries for fish
- General (32%):
 - Make them fly fishing only or don't open them



Modify Trout fishing opportunity in select Western Washington streams

- Consistent with stream strategy
- Open portions of streams above anadromous barriers
- Close portions of streams where concern exists for wild salmonids

Modify Trout fishing opportunity in select Western Washington streams (27)

Pro (56%):

- Include Leland Creek (has bass and catfish)
- Include the North Fork of the Skykomish
- Include more catch and release opportunities
- Keep the upper North Fork Sauk and tributaries a quality catch and release fishery

Con (26%):

- Counter-productive to native steelhead
- Keep upper North Fork Sauk and tributaries catch and release

- General (18%):

Make all selective gear rules







Increase selective gear fishing opportunity

- Public input for additional selective gear lake fishing opportunity in Western Washington
- Six lakes in Snohomish County provided for consideration (Chain; Martha (Warm Beach); Ballinger; Flowing; Lost (Devil's); Panther.

Increase selective gear fishing opportunity (36)

- Pro (72%):
 - Yes for Chain and Martha lakes
 - More opportunities to catch holdover trout
 - 2 fish daily limit encourages anglers to release fish
 - Consider Selective Water endorsement license
- Con (14%):
 - Limits trout fishing
 - Majority of anglers for these lakes fish from banks with bait
- General (14%):
 - Bait fishing from shore is most effective
 - Many locals don't have a boat to troll

Cross Region Proposals Require mandatory hatchery Steelhead retention



- Reduces potential for unwanted genetic and competitive interactions with wild steelhead
- Applies to streams where hatchery fish are planted and hatchery production goals are being met

Require mandatory hatchery Steelhead retention (59)

- Pro (75%):
 - Need to see if the wild fish can make it on their own;
 - Maintain a daily limit on harvestable fish;
 - Yes, for stream with recoverable wild steelhead component
- Con (17%):
 - Limits time one can fish, especially for multi-day fishing trips
- General (8%):
 - Make it a statewide rule
 - Problem without an increase or change in steelhead limit
 - Problem without change in rules on wastage

- Allows anglers to fish with
 2 poles
- Provides additional recreational opportunity



Puget Sound Proposals—Region 4 Pass Lake (Skagit Co.): Allow 2-pole opportunity (34)

- Pro (38%):
 - Will not ruin experience
 - One pole at a time
- Con (50%):
 - Change may upset local experience (effort, quality)
 - Increased hook and release mortality
- General (12%):
 - Don't think it is possible/necessary to fly fish with 2 rods

Washington Department of Fish and Wildlife; Information subject to changes and amendments over time Rattlesnake Lake (King Co.): Allow Trout harvest

- Currently catch and release
- Public requests rule that allows for harvest of some trout

 Two fish daily limit, 14 inch minimum length

Puget Sound Proposals—Region 4 Rattlesnake Lake (King Co.): Allow Trout harvest (30)

Pro (47%):

- Area wants local catch and keep opportunity (families/kids)
- Various modifications: 1 over 18", 2 over 16"
- Non native fish should be harvested.
- Con (50%):
 - Only catch & release lake in King County
 - Give the C&R change a chance
 - Will be fished out by summer's end
- General (3%)

Pro(20%)

- Agreement with the proposal
- Con (73%):
 - 10 years of senior's derbies impacted (Auburn Parks)
 - Stocking for derbies benefits juveniles
- General (7%)

Sammamish Lake (King Co.): Remove hook restrictions



 Remove single point barbless hook restrictions

 Changes in Kokanee management make barbless hooks unnecessary

- Pro(38%)
 - Rule simplification
 - Increase retention of cutthroat predators
- Con (62%):
 - Better to err on the side of continuing conservation efforts
 - Not needed to access cutthroat

North Coast Steelhead Four major concepts proposed



#46, 47, 48, 49

 Adopt "no fishing from floating device" rules on select streams

- Selective gear rules
- Prohibit harvest of wild steelhead and trout
- Require wild Steelhead harvest tag

North Coast Steelhead Department engaged ad-hoc North Coast Steelhead Advisory Group



- Diverse group focused solely on North Coast
- Met 6 times since July
- Great compromise by all members
- Developed a comprehensive package of recommendations
- Not all components supported by all members

Advisory Group Package

Consider revising in three years.

- 1. Prohibit use of internal combustion motors.
- 2. Remove "Selective Gear Rules" and replace with:a) Barbless hooks during steelhead season.b) Only one hook with up to three points.
- 3. Limit bait to times and places with hatchery steelhead
- 4. Release wild steelhead and rainbow trout.
- 5. Prohibit fishing from floating devices on Hoh River above Morgan's Crossing.

Advisory Group Package

- Longer term issues
 - ✓ Consider limits on the number of guides that are allowed to operate on the North Coast rivers.
 - Educate the angling public to encourage proper handling of fish.
 - Create an "endorsement" for fishing for steelhead in North Coast streams.
 - Escapement goal level (believe too low)
 - ✓ Productivity
 - ✓ State-Tribal sharing

#46. Adopt "no fishing from floating device" rules on select streams (661)

- Pro (~ 50%):
 - Rivers are under intense pressure and this creates high interaction rate with wild steelhead
 - Include Hoh River because of variable escapement
 - Apply to Humptulips, Satsop, and Wynoochee
 - Promotes more orderly fishery
- Con (~ 50%):
 - Oppose except for Dickey, Salmon (outside Olympic Park and QIN Reservation) and the Snahapish
 - Cuts off large pieces of water from fishing because of unsafe bank conditions
 - ADA fishers unable to fish on the bank

#47. Selective gear rules (462)

- Pro (>90%):
 - Bait kills more fish than any artificial lure
 - Ban wild steelhead fishing entirely
 - Rivers contain the last viable populations of wild steelhead
 - Require single, barbless hooks
- Con (<10%):</p>
 - Proposal is for benefit of a specific user group

48. Prohibit harvest of wild steelhead and trout (634)

- Pro (>90%):
 - Full support, apply rule statewide
 - Preservation of wild Steelhead and Rainbow Trout
 - Assure fishing experience for future generations
 - Time is right.
- Con (<10%):</p>
 - Don't over-regulate these rivers
 - Radical proposal; there are still catchable numbers of wild fish

49. Wild Steelhead harvest tag (111)

- Pro (33%):
 - Agree provided require ALL steelhead anglers purchase a punchcard
 - If wild Steelhead harvest is allowed, then yes
 - Limits number of wild fish poached
- Con (67%):
 - Wild Steelhead should be prohibited
 - Counterproductive and reduces opportunity
 - Enact a statewide Zero Kill policy
 - Limits opportunity to wealthy only

Lower Columbia Warmwater Proposal Liberalize limits for Bass, Channel Catfish, and Walleye in the Columbia River and tributaries contiguous with Oregon



- Remove harvest limits for Walleye, Bass and Channel Catfish
- Consistent with rest of Columbia River


Lower Columbia Warmwater Proposal

Liberalize limits for Bass, Channel Catfish, and Walleye in the Columbia River and tributaries contiguous with Oregon (35)

- Pro (66%):
 - Invasive species, proposal makes sense;
 - Much invested in salmonid recovery in the Columbia; don't jeopardize with non-native predators.
- Con (34%):
 - Science does not support;
 - Can't blame salmon and steelhead run sizes on warmwater fish;
 - Warmwater fish are important to the economy;
 - Trophy size walleye being diminished.
