#### Why Annual Season Changes are Needed

- Changes in clam and oyster abundance
- Overharvest of the states share during previous season
- Changes in projected effort and catch
- Changes in water quality and public health concerns
- Housekeeping(language clarification) changes

- Rule change proposal e-mailed to recreational fishing information contact list (approximately 1,700 contacts)

Sequim Bay State Park	April 1 – June 30	2 months	Both
Freeland County Park	March 1 – May 15	1 month	Both
Point Whitney Lagoon	January 1 – April 30	1 month	Clam
Twanoh State Park	August 1 – September 30	1 month	Clam
P.T. Ship Canal	January 1 – July 31	0.5 month	Both

### 2016 Proposed Clam and Oyster Season Changes – Decreases

Location	Proposed 2016 Season	Season Length Decrease	Species
Indian Island County Park	August 15 – September 15	- 0.5 month	Both
Oak Bay County Park	May 1 – May 31	- 1 month	Both
Fort Flagler State Park	May 15 – August 31	- 4 months	Both

### 2016 Clam and Oyster WAC Changes - Public Health

Change Made	Clam and Oyster Beaches Affected	Season Length
Permanently Closing	19	72 month decrease

- Reasons for closure include:
  - Codify existing health closures
  - Request from state and/or county health jurisdiction or state parks
  - General housekeeping
