- Changes in clam and oyster abundance
- Prevent overharvest of the state's share
- Changes in projected effort and catch
  - Distribution of extreme low tides to maximize opportunity
- Changes in water quality, public health concerns
  Housekeeping (language clarification) changes

West Penn Cove	June 1 – Dec. 31	- 5.0 months	All bivalves	Pressure reduction/ butter clams

## 2017 Clam and Oyster WAC Changes - Public Health

Change Made	Clam and Oyster Beaches Affected	Season Length
Permanently Closing	2 clam; 4 oyster	48 month decrease
Upgraded to Open	2	24 month increase

#### □ Reasons for changes include:

- Codify existing health closures or upgrades
- Request from state and/or county health jurisdiction or State Parks
- General housekeeping including name corrections and clarifications

#### 2017 Clam—Unlawful Acts WAC

- Increasing size limit for Quilcene Bay WDFW Tidelands
  - Co-managers agree: lack of conservation need for smaller size limit
  - Standardizes minimum clam size on all public beaches to 1.5"
    - Smaller clam gauge not commercially available
