# 9. Amending the Coastal Recreational Crab Rules – Briefing, Public Hearing and Decision Heather Reed, Intergovernmental Ocean Policy Coordinator briefed and requested approval from the Commission on proposed regulations for providing coastal recreational crab fishing opportunities.
