### 1. Call to Order

Chair Baker called the meeting to order at 8:02am. ([Begins at 0:01 mark](#))

#### Commissioner's Discussion

Commissioner Rowland reported that for the last few years a pair of Sandhill Cranes have nested in one of the Methow Valley's wildlife areas. She noted that WDFW has made the permanent decision to close a section of that wildlife area for the cranes to be able to nest. She went on to comment about how a couple of WDFW Staff were giving a presentation at a continuing education event she attended and how good of a job they did at that event. The last thing she reported on was the total eclipse of the moon. ([Begins at 1:48 mark](#))

#### **Committee Meeting Updates:**

Commissioner Lehmkuhl reported out that the Big Tent Committee met yesterday from 10am-12pm. The meeting started with a quick update on the Conservation Policy. The Department is in talks with the Tribes about the policy. There was a brief conversation about the Ruckelshaus Report, and made a list of recommendations from the report, and the best way the Commission should respond to the report. There was also a discussion about some options for early input on the budget and legislation. The Committee is recommending that the Commission adopt option 2. There was also a presentation on the Integrated Science Policy (previously the Best Available Science Policy). The Committee is recommending that the Commission approve the policy that's being presented later in the day. There was also a second recommendation that the Commission assigns the Big Tent Committee the task to work with staff to revisit the decision-making process that was in the original policy. Chair Baker asked

if anyone was opposed to agreeing to the Committee recommendation of option 2 for the budget and policy development, and there were no objections. ([Begins at 10:22 mark](#))

Commissioner Anderson reported out that the Fish Committee met yesterday and heard presentations on Mid-Columbia white sturgeon management, the statewide trout management, and the Commercial Dungeness Crab Rules, in particular, the coastal comprehensive line marking rules. There was a request to delegate rulemaking to the WDFW Director and the Committee is recommending to the full commission that it be delegated as requested. ([Begins at 22:45 mark](#))

## **3. Director's Report**

Director Susewind reported out that there are a couple of ongoing meetings with the Tribes. He recently met with some members of the Coeur d'Alene Tribe for the first time and members of the Quinault leadership team to discuss concerns and areas of interest with each. The Department held its safety standup week from February 24<sup>th</sup>-27<sup>th</sup>. The kick-off meetings for North of Falcon and PFMC in Vancouver. He also recently held public hearings for the delegated season settings that are outside of Cougar and Bear. He anticipates that decisions will be made in the near future. He went on to note that there are currently five petitions under review waiting to be acted on and he briefly touched on the petition topics. For budget, he didn't have a lot to report on, and the bills at the legislature are moving along well. He was hoping to have more to report on the budget, but this year is a strange year. The Department is focusing its energy on its own packages, and aren't focusing on being aggressive for additional, but more defensive for not cutting. He noted that staff are keeping an eye on the federal cuts being made, and thus far, it hasn't affected the Department.
