- That immediate adoption, amendment, or repeal of a rule is necessary for the preservation of the public health, safety, or general welfare, and that observing the time requirements of notice and opportunity to comment upon adoption of a permanent rule would be contrary to the public interest.
- That state or federal law or federal rule or a federal deadline for state receipt of federal funds requires immediate adoption of a rule.
- That in order to implement the requirements or reductions in appropriations enacted in any budget for fiscal year 2009, 2010, 2011, 2012, or 2013, which necessitates the need for the immediate adoption, amendment, or repeal of a rule, and that observing the time requirements of notice and opportunity to comment upon adoption of a permanent rule would be contrary to the fiscal needs or requirements of the agency.

Reasons for this finding: Preliminary estimates indicate that the encounters of legal size Chinook in Area 7 are projected to exceed the pre-season expectations. This regulation reduces the retention of salmon in Area 7 to a daily limit of one in order to minimize encounters of legal size hatchery and wild Chinook and ensure compliance with conservation objectives and agreed-to management plans. There is insufficient time to adopt permanent rules.

NEW SECTION

WAC 232-28-62100A Puget Sound salmon—saltwater seasons and daily limits.

Notwithstanding the provisions of WAC 232-28-621, effective February 24 through April 30, 2014, it is unlawful to violate the provisions below. Unless otherwise amended, all permanent rules remain in effect:

Catch Record Card Area 7: Daily limit of 1 salmon and release wild Chinook.

REPEALER

The following section of the Washington Administrative Code is repealed effective May 1, 2014:

WAC 232-28-62100A Puget Sound salmon—saltwater seasons and daily limits.
