EMERGENCY RULE

Under RCW 34.05.350 the agency for good cause finds:

- That immediate adoption, amendment, or repeal of a rule is necessary for the preservation of the public health, safety, or general welfare, and that observing the time requirements of notice and opportunity to comment upon adoption of a permanent rule would be contrary to the public interest.
- That state or federal law or federal rule or a federal deadline for state receipt of federal funds requires immediate adoption of a rule.
- That in order to implement the requirements or reductions in appropriations enacted in any budget for fiscal year 2009, 2010, 2011, 2012, or 2013, which necessitates the need for the immediate adoption, amendment, or repeal of a rule, and that observing the time requirements of notice and opportunity to comment upon adoption of a permanent rule would be contrary to the fiscal needs or requirements of the agency.

Reasons for this finding: This emergency rule is needed to address new activity the Department of Fish and Wildlife has identified in the Washington coastal shrimp fishery that compromises enforcement and protection of the pink shrimp resource. There is insufficient time to adopt permanent rules. The department is initiating permanent rule-making to address this issue.

NEW SECTION

WAC 220-52-05000A Ocean pink shrimp trawl fishery – Coastal waters.

Notwithstanding the provisions of WAC 220-52-050, effective immediately, it is unlawful to violate the provisions below, except as allowed by a shrimp trawl fishery permit:

- (1) Fail to deliver ocean pink shrimp landings to a processing facility located on shore;
- (2) Process ocean pink shrimp at-sea;
- (3) Freeze ocean pink shrimp at-sea; or
- (4) Transfer pink shrimp catch from one fishing vessel to another.

A violation of this section is punishable under RCW 77.15.750, unlawful use of a department permit.

EMERGENCY RULE ONLY

Under RCW 34.05.350 the agency for good cause finds:

(x) That immediate adoption, amendment, or repeal of a rule is necessary for the preservation of the public health, safety, or general welfare, and that observing the time requirements of notice and opportunity to comment upon adoption of a permanent rule would be contrary to the public interest.

() That state or federal law or federal rule or a federal deadline for state receipt of federal funds requires immediate adoption of a rule.

() That in order to implement the requirements or reductions in appropriations enacted in any budget for fiscal years 2009, 2010, 2011, 2012 or 2013 which necessitates the need for the immediate adoption, amendment, or repeal of a rule, and that observing the time requirements of notice and opportunity to comment upon adoption of a permanent rule would be contrary to the fiscal needs or requirements of the agency.
